*The Annual Meeting will take place at Oxford Early Childhood Center on August 22, 2024 as an in-person meeting. This document will be discussed at that time. Parents are provided frequent academic achievement reports including Progress Reports each nine weeks (October, January, March, and May), MKAS Parent Reports, and Power School Reports related to student attendance. Important reports and standardized assessment dates, as well as regular and on-going information, will be announced using parent newsletters, social media, both the school and district websites, and principal newsletters. Parent conferences will be held three times a year to discuss student assessment data and parents will be provided additional resources to help work with their children at home.*

- d - Provide parents reasonable access to staff.

*Parents may request a conference or a meeting with the teacher by either calling the school at 662-371-1630, by sending a note in your child's folder, or sending an e-mail message to the teacher.*

- e - Provide parents opportunities to volunteer in their child's school and to participate in school activities.

*Every parent will be invited to attend at least one face-to-face conference during the first semester. During this conference, your child's progress, daily work habits, areas of attention and classroom behavior will be discussed. Additional conferences may be held, as requested by parents or teachers, and may be scheduled by calling the school office (662-371-1630) or via written communication including email.*
