New York State English Language Arts & Math Assessments

Ms. Jennifer Rylott reported that for the New York State English Language Arts exam, for students in grades 3-8, the District had a participation rate of 54% and for the New York State Math exams for students in grades 3-8, the participation rate for our District, was 58%. This is much lower than the 95% participation rate required by the State, but not very different from last year.
