Optional Attendance Zone Information for New Entrants Only

Greetings:

The Board of Education of the Great Neck Public Schools is pleased to offer an "Optional Attendance Zone" choice to current 5th grade students who live in the E.M. Baker and Saddle Rock attendance areas, who are zoned to attend South Middle School, and who are *fully registered and enrolled* in 6th grade by September 30, 2025. Ideally, 35-40 students will elect to attend North Middle School. Students electing to attend North Middle School must remain continuously enrolled in the Great Neck Public Schools in order to attend North Middle School through 8th grade, and to continue at North High School for grades 9-12. Guidelines for new registrants apply to students whose enrollment in the Great Neck Public Schools is not continuous All students who exercise this option are eligible for transportation if they reside beyond North Middle School's "walker" limits, and their younger siblings will be provided with the same "Optional Zone" choice when they reach 6th grade. Please note that older siblings who are not presently enrolled at North Middle School or North High School are not eligible.
