Budget Presentation

Mr. Skuggevik welcomed everyone to the fourth budget presentation in preparation of the 2015-2016 school budget, and presented the topics of Capital (Plant Operations, Maintenance, Equipment, and Debt Services), Athletics, and Cafeteria.

While reviewing the budget line for Principle & Interest: Generator for Town Emergency Shelter Bond, Ms. Linda Eklund asked why the dollar amount for this line jumped over \$8,000 from the 2014-2015 budget to 2015-2016 budget. Mr. Skuggevik stated that he will research this further.

At the time of the Athletics portion of the presentation, Mr. Todd Gulluscio presented an overview of the Athletic Teams for 2015-16, the participation for these programs and the benefits of educationally based athletic programs. Mr. Skuggevik then presented the Athletics Budget.
