General Presentation

Mr. Brian Becker explained to the Board of Education that he has requested to speak at each monthly meeting, in order to give a report of the exciting things the members of the Shelter Island Faculty Association (SIFA) are doing in the building. Mr. Becker also hopes this monthly report will allow for the opportunity for SIFA and the Board to have an open dialogue.

Mr. Becker reported that 15-20 SIFA members have formed a book club this year. They are reading, <u>Teach Like a Pirate</u> and the group meets bi-weekly.

Along with the two other parents, Ms. Springer asked the Board of Education to reconsider placing this item on the May 19, 2015 ballot.

Dr. Stephen Gessner explained that he appreciated Ms. Springer's efforts at this petition, but the District has to follow legal counsel and the Board was advised that the correct procedure was not followed. Dr. Gessner explained it was too late for anything to be added to the ballot at this time, but it would certainly be considered for next year's ballot if everything is submitted correctly.

Ms. Linda Eklund suggested that the petition be submitted earlier than 60 day prior to the vote. This would allow time for legal counsel to review and if anything is missing or incorrect, the Board of Education could pass the feedback to Ms. Springer for correction, before the final due date. Mr. Skuggevik also offered up the same suggestion.

At this time, Dr. Gessner thanked the parents for coming and presenting their ideas and documentation.
