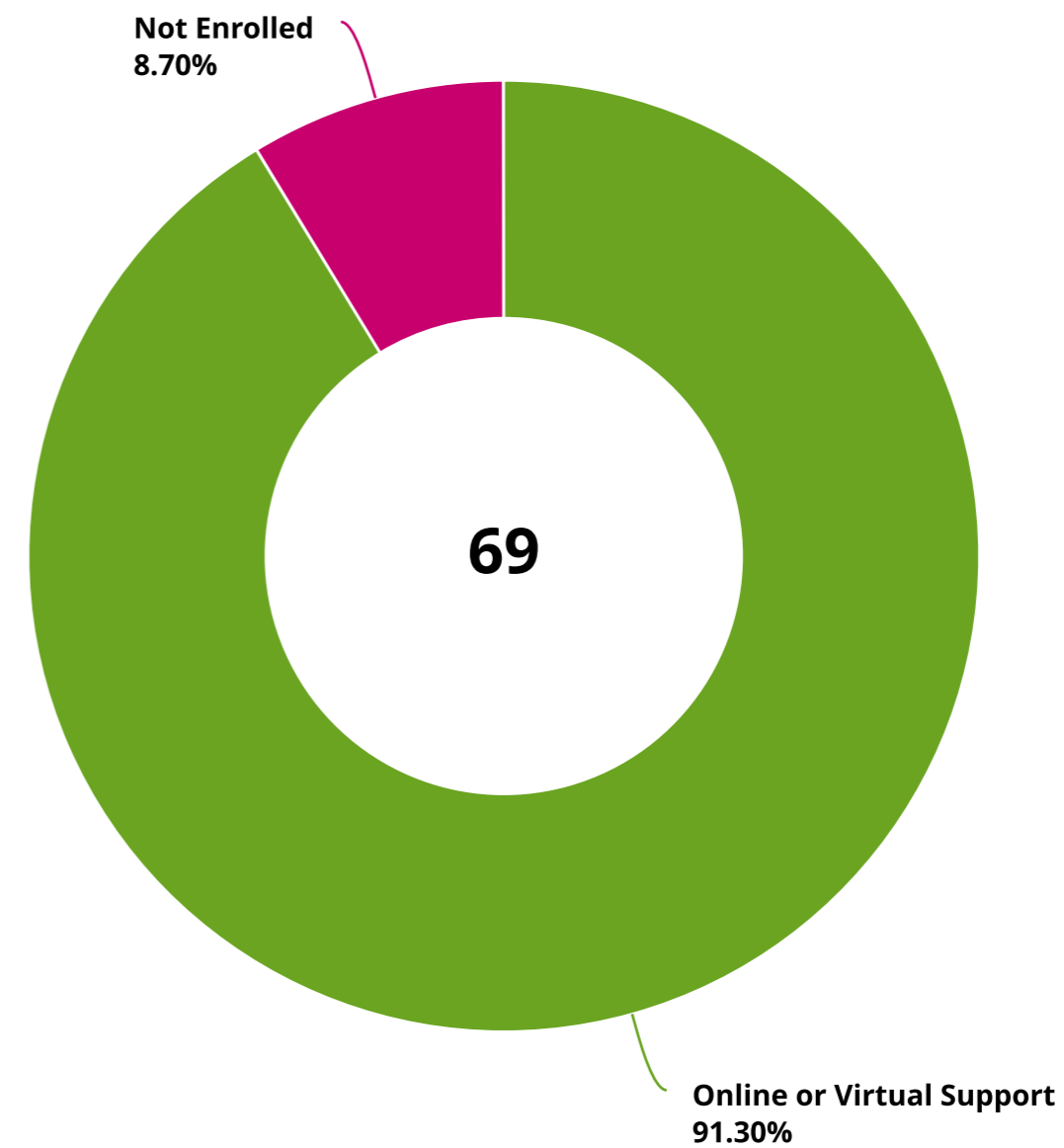

School Enrollment in Your District by Support Type





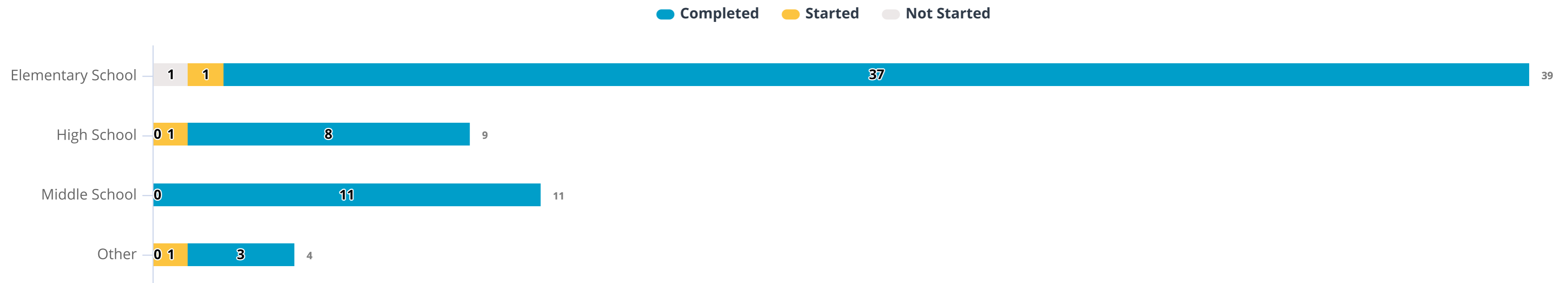

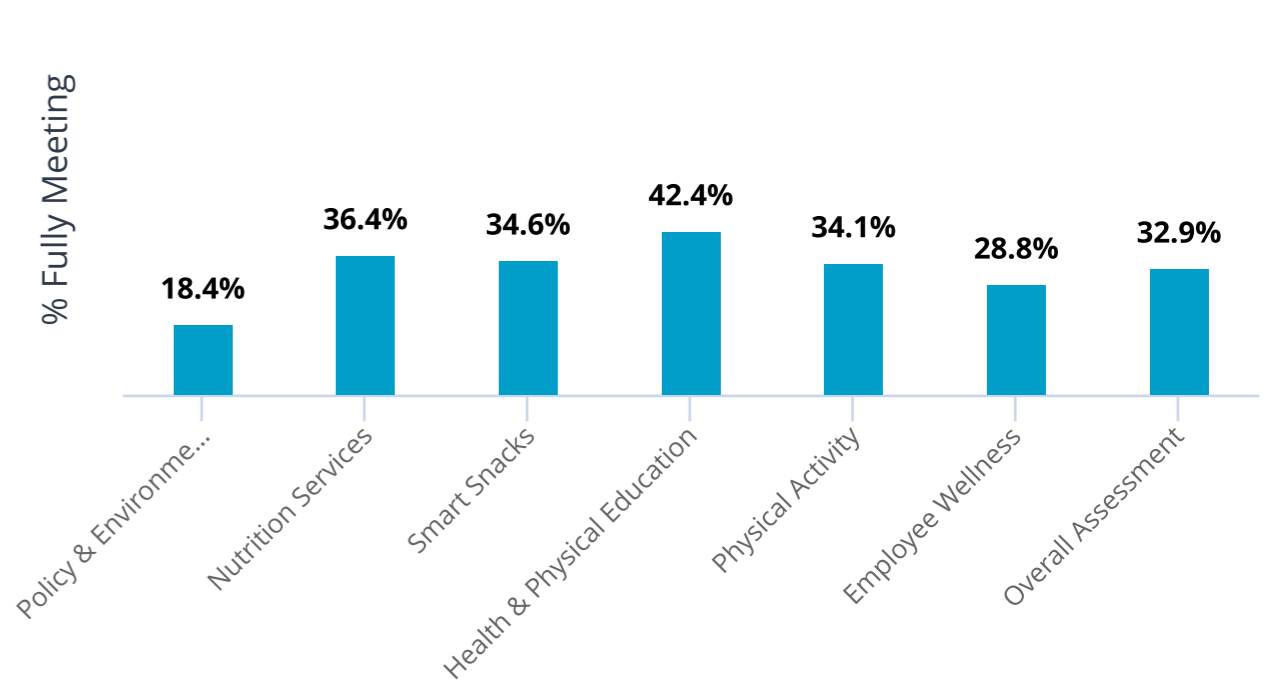
KY | District % Fully Meeting by Module



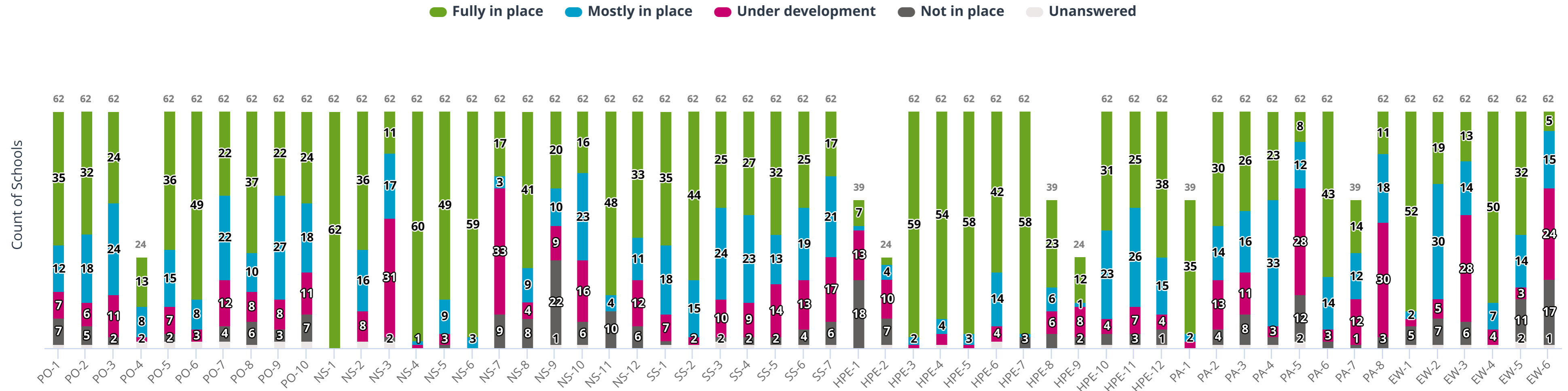
KY | State % Fully Meeting by Module

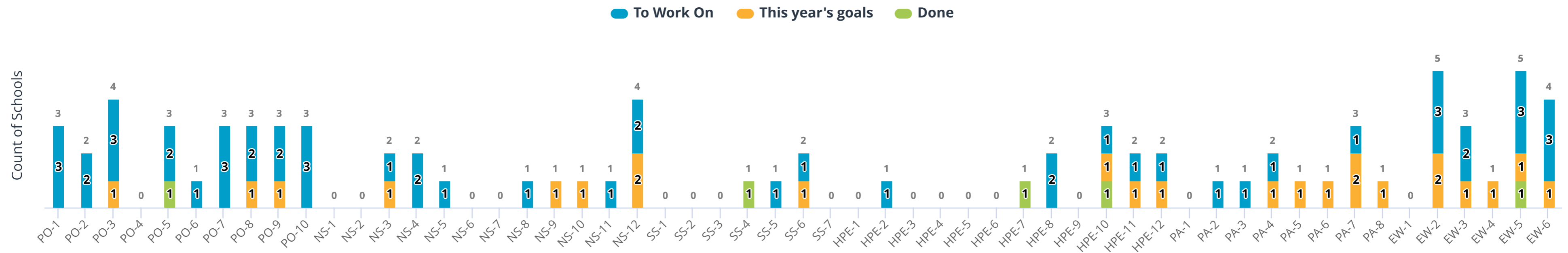

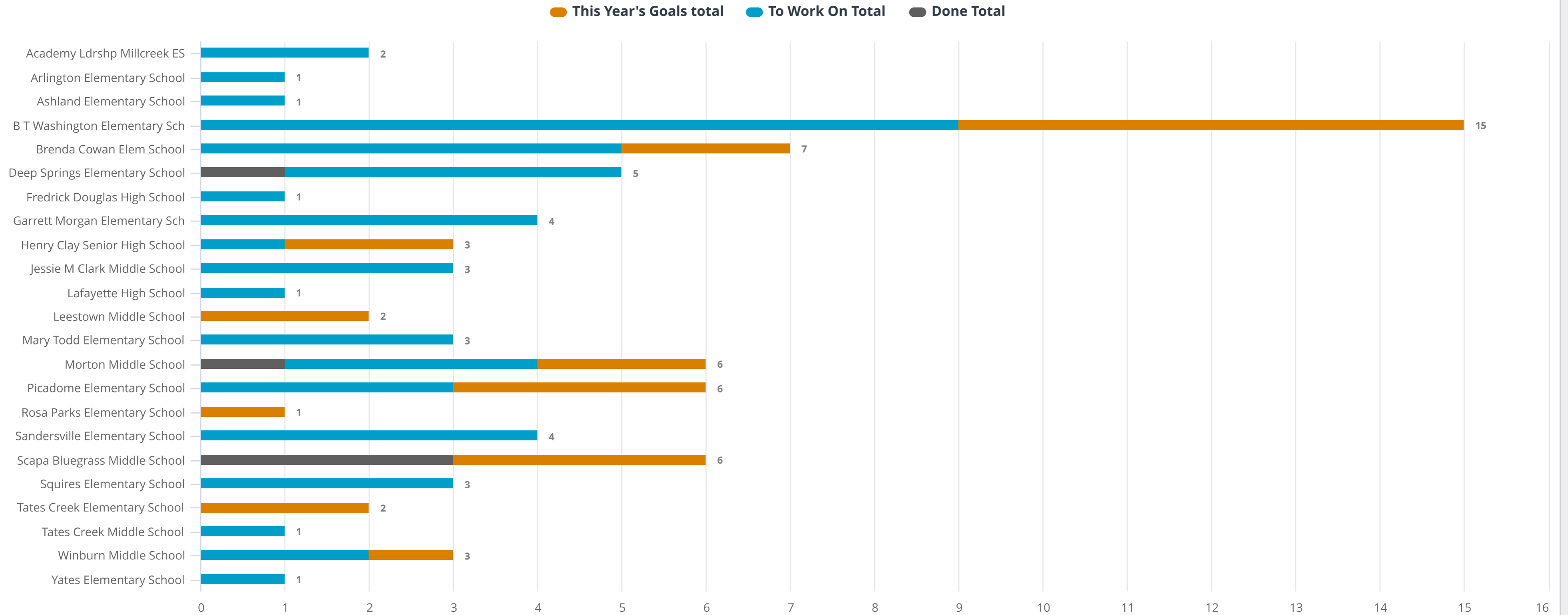

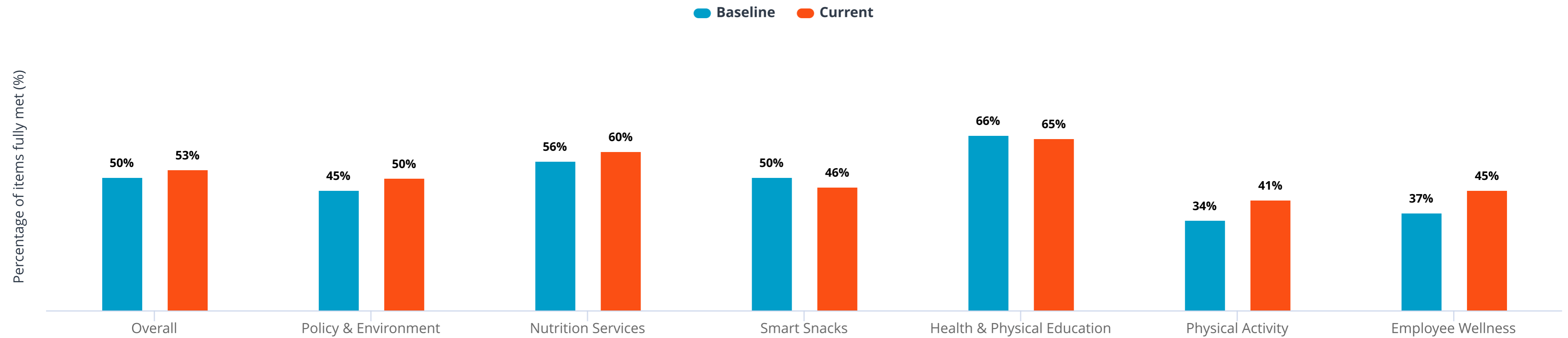
