FINAL ACCEPTANCE OF CONSTRUCTION COMPLETION**

A RESOLUTION of the Board of Directors of Highline School District No. 401, King County, Washington, accepting construction of the Puget Sound Skill Center - Electrical Infrastructure Preservation Project as complete.

WHEREAS, funding for the Puget Sound Skill Center - Electrical Infrastructure Preservation Project was made available through the Office of Superintendent of Public Instruction; and

WHEREAS, following a competitive bid, Brink Electric LLC was awarded a contract as the lowest responsive, responsible bidder to construct the Puget Sound Skill Center - Electrical Infrastructure Preservation Project; and

WHEREAS, the construction work related to the Project was completed as of February 20, 2024; and

WHEREAS, the School District has paid Brink Electric LLC \$575,741.82. including change orders and Washington State Sales Tax (WSST) relating to the Project: and

WHEREAS, a retainage bond is in place pursuant to RCW 60.28.011(6): and


WHEREAS, Brink Electric LLC has provided an "Affidavit of Wages Paid" for itself, and each Subcontractor of any tier: and

WHEREAS, the Office of Superintendent of Public Instruction requires the Highline School District's Board of Directors to adopt a resolution of Final Acceptance of construction of Puget Sound Skill Center - Electrical Infrastructure Preservation Project.
