The meeting was called to order at 7:05 p.m. by President Gessner Call To Order

Dr. Michael Hynes welcomed everyone to the fourth budget workshop in preparation of the 2012-2013 school budget.

The topics presented for this meeting include Board of Education Budget Goals; the 2012-2013 Tentative Expenditure Budget – Administrative, Capital and Program Components and Highlights of Improvements and Reductions; "Tax Cap" and Shelter Island UFSD Specific Figures; 2012-2013 Tentative Revenue Budget; and the Budget Calendar. Dr. Hynes stated that the budget to budget potential increase will be 1.02% and the potential increase for the levy would be 1.96%. Dr. Hynes explained that if the budget were not passed by the voters, then \$170,816 in cuts to the 2012-2013 proposed budget would have to be made.

Dr. Hynes reviewed some of the 2012-2013 improvements and reductions. Improvements include new course offerings, having an academic official, K-1 combined classroom, and team teaching in the 3rd and 4th grades. Some of the 2012-2013 reductions include changes to the Business Office, a 1.0 FTE Custodian, materials/supplies/equipment (contractual expenses), some athletics, field trips, and co-curricular and extra-curricular activities.

Dr. Hynes and the District Clerk reviewed some important dates regarding the budget vote and election of Board of Education members. The information being presented can be found on the schools' website, as well as on Town Channel 22.
