WHEREAS, the Board of Education of the Shelter Island Union Free School District wishes to systemize the design of the 2012-2013 budget with several universal goals; and

WHEREAS, the Board of Education of the Shelter Island Union Free School District recognizes that it has been entrusted by the residents of the school district to prioritize programs and appropriate tax dollars to fund said programs; and

WHEREAS, the Board of Education of the Shelter Island Union Free School District retains its right to make any changes to the proposed budget up to the date of adoption for presentation to the voters;

NOW, THEREFORE BE IT RESOLVED that the Board of Education of the Shelter Island Union Free School District hereby adopts the following budget goals for the 2012-2013 school year:

- 1. To design and adopt a budget that stays within the 2% Tax Cap limitations.
