Visitor's Comments

- A. Ms. Judy Card asked the board to re-consider their decision not to appoint Jennifer Rylott and to look at all of the options that are available and think about what the right decision would be.
- B. Ms. Jeannette Payne asked the board if they received the signed petition. Ms. Mundy responded yes.
- C. Mr. Andy Payne asked the board if the community will have a chance to speak at the end of the meeting. He also asked if the Board can concisely tell him what the motivation was to deny the position to Jennifer Rylott.

D. Ms. Mary Boeklen stated that she would like the board to change their mind, and parents and kids want the Board of Education to re-consider also. This is the students' chance to take steps to the next level. Ms. Rylott is the person for that, and the parents feel the same way.

Visitor's Comments (con't)

- E. Ms. Liz Lechmanski seconds Judy Card's request to re-consider. She implores the Board of Education to re-consider on behalf of parents and students.
- F. Ms. Jeannette Payne asked about 5th grade balanced literacy and who is going to train the new teacher. She commented she feels sorry for the 5th graders. Ms. Jennifer Rylott wrote the curriculum for the Middle School.
- G. Ms. Kyle Karen stated that it is a big job teaching ELA, and the district needs a teacher with experience. The Board of Education is obligated to find someone with the same experience.
- H. Mr. Andy Payne stated it is astonishing to him that the board cannot see the tremendous job Mrs. Clifford has done. It is a gigantic mistake.
- I. Ms. Fokine commented that she has 2 children in the school with Ms. Rylott, and it is a shrouded mystery that Ms. Rylott wants to take the next step and the door was slammed shut. Ms. Fokine is upset because she does not have all of the information she needs.

A. Ms. Rebecca Mundy stated the board received a petition consisting of 105 signatures. The Board also received correspondence from Mary Boeklen, Kyle Karen, and Lee Oliver regarding the same request for the board to re-consider moving Ms. Rylott.
