The meeting was called to order at 5:36 p.m. by President Mundy, followed Call To Order by the Pledge of Allegiance.

Correspondence -

Correspondence

A. Ms. Rebecca Mundy received correspondence regarding the district's transportation policy and the mileage limitations. The law states that the district has to transport children in grades K – 8 who live more than 2 miles from the school and for students in grades 9 -12 who live more than 3 miles from the school. Ms. Mundy stated that the district has reviewed their policy and cannot find a public referendum that states the district has to transport under the 2 mile limitation. She stated that it has been the districts' past practice to transport 2 miles for students in grades K-12; however, the policy does not state any age or grade. The Board of Education will take this information under advisement. The District Clerk will also continue to research this topic.

B. Ms. Rebecca Mundy also received a memo from Sam Schneider, School District Business Leader, regarding the addition of Girls Field Hockey as a sport offered in the Fall. The Board asked Mr. Schneider the options available to run this sport, since it was not budgeted for nor discussed prior to this meeting. Mr. Schneider stated that approximately \$6,500 must be cancelled from somewhere else in order to be able to run Field Hockey. Also, the district, under Title IX, must offer equal amounts of sports for boys and girls. One option is to eliminate Junior High Softball due to the low number of students who signed up. This is a concern for the Board, as that may change as the Spring season approaches. Most Fall Sports teams will be starting practice on August 31st, and the Board of Education has not given any instruction regarding Field Hockey.

Ms. Mundy would like the administration to communicate with Mr. Rick Osmer, Jr., Athletic Director, about what sport to eliminate. One possible solution mentioned by the Board is to create a Booster club. It was stated that an outside program can raise funds and earmark those funds for sports, but a Booster Club cannot go to parents and ask them for money in order to run a sport. Ms. Linda Eklund suggested that they can take from JH Softball now and fundraise for Softball in the Spring. Mr. Schneider will talk with the Athletic Director, but cautioned he does not want to run the sports program so tight.
