- **C.** Ms. Rebecca Mundy asked about the letter received by the Board of Education from the State Education Department regarding the FIT Center. Ms. Mundy handed out a draft agreement between the school and town, which the Board of Education needs to review by the end of the week. The FIT Committee has given Ms. Mundy a list prioritizing projects regarding the FIT center, which will be given to the Board of Education. Projects will be looked at after the agreement has been signed.

**A.** Ms. Mary Kanarvogel asked the Board about the money left over from prior classes and what was going to be done with that money.

**B.** Mr. Draper commented to the Board that the activity of budgeting is still a big black hole and that the community needs to be aware. He suggested that he can be an ambassador and make suggestions in the communication process. Mr. Draper is happy to stay involved, and also commented that the budget is a critical juncture for this Board, and they need to be ready.
