Ms. Mary Dwyer, coordinator, did a presentation to the Board on the 2Rs4Fun program, which was an after school, out-of-school, creative writing program for 3rd and 4th grade students. With the cooperation of Denise DiPaolo, Shelter Island Library Director, and Mrs. Sharon Clifford, Superintendent, Ms. Dwyer recruited 16 mentors to work one-on-one with 16 students to implement a 4 Phase process approach to literary writing. This included training mentors and students the importance of literature and its effect on creative writing, having book discussions and journal writings based on what was read, having the students create a writer's notebook and personal journal which was used to develop fluency, and having writing workshops where more formal writing was done. At the end of the session, the students put a book together, where the students saw themselves as writers and had their own voice in their writing. Ms. Dwyer commented that the students were amazing, very enthusiastic, special, and the program was a wonderful experience. She asked the Board of Education to keep supporting this type of program. Mrs. Clifford thanked Ms. Dwyer for her support and the long hours she put in to create this program.
