**DISTRICT MEETING BUDGET RE-VOTE  
June 17, 2008**

The Budget Re-Vote of the Shelter Island Union Free School District, Town of Shelter Island, County of Suffolk, State of New York was held at the school in said district on June 17, 2008.(Affidavit of Publication is attached to these minutes.)

The meeting was called to order at 12 p.m. by President, Robert Reylek.

Call to Order

The District Clerk read the Purpose of the Meeting:

Purpose of Meeting

In accordance with the provision of Chapter 101, Laws of 1953, the District Clerk of the Shelter Island Union Free School District, Town of Shelter Island, County of Suffolk, State of New York, hereby gives notice to the inhabitants of the Shelter Island Union Free School District, qualified to vote, that at the meeting the Board of Education will submit the Proposed Annual District Budget for re-vote for the Fiscal Year 2008-2009.

Proposition 1: Shall the Shelter Island Union Free School District Budget in the amount of \$9,499,918 for the fiscal year 2008-2009 be approved as proposed and the requisite portion thereof raised by taxation on the taxable property of the district?

At 12:00 p.m., prevailing time, Tuesday, June 17, 2008, the District Meeting of the Shelter Island Union Free School District, Town of Shelter Island, County of Suffolk, State of New York, of June 17, 2008, was called to order by the President, Board of Education, Robert Reylek.

The polls were declared officially opened at 12:00 p.m., prevailing time and announced that they would remain open until 8:00 p.m., prevailing time for the purpose of voting by machine for the Proposed Annual District Budget, as presented for re-vote, for the fiscal year 2008-2009.

At 8:00 p.m., prevailing time after ascertaining that everyone in the building at that time had voted, Deborah Vecchio announced the results to those assembled:
