

2024 Tools for Schools Survey Results


Overview: This survey is a collection of questions crafted over time by our long standing Tools for Schools Committee at Beecher Road School. This year the survey was sent out September 10th 2024 and left open 10 days. We had 48 responses. Upon review of this survey 2 separate building walkthroughs will be conducted by the committee to inspect and evaluate concerns. Upon receiving the results the committee expressed interest in altering the timing of the survey. Possibly coordinating the release with a staff meeting to raise awareness about the purpose of the survey and work to improve the number of respondents.

NOTES: The 1 "No" was from a new staff member. Upon receipt of the survey the staff member was alerted to the location of ventilation in the space. The 1 "N/A" was from a shared space. The other occupant of the room was aware of the location of the ventilation.






NOTES:The 4 "No" responses were located and 4 different areas of the building. All custodial staff members were reminded about cleaning every sink every evening.


Trash receptacles are emptied daily.

NOTES: The custodian who received the 1 "No" response was alerted to the issue.


Classroom carpets and floor areas are vacuumed and swept daily. 48 responses


Classroom lavatories are free of leaks and odors


Areas around and under classroom sinks are free of leaks 48 responses




NOTES: All "Yes" responses. No action has been taken.


NOTES: The 5 "No" responses had varying locations. 2 pairs of the room were adjacent, the final room was in a different area. More investigation is needed.



NOTES: The 1 "No" response was from a room also with classroom and bathroom odor. More investigation is needed.


Ceiling tiles and walls are free of leaks (discoloration may indicate periodic leaks or condensate drip)



The final "No" response was from the Science Lab and an active roof leak investigation is ongoing.


I understand which areas (i.e. desks) are not cleaned by custodians, and I maintain them regularly 48 responses




NOTES: The "N/A" responses were people who do not occupy classroom spaces.




NOTES: All 5 "No" responses were from office spaces or multi-grade shared spaces.





NOTES: One of the 2 "No" responses was from a new staff member who has already worked to improve the space. The other no was from a multi-grade classroom.


I have seen evidence of pests or vermin in my space during September 2024 48 responses

Classroom supplies are stored according to manufacturers' recommendations (i.e. paints, dry erase cleaners)




Exposure to hazardous materials (i.e., used non-hazardous materials and pre-mixed products) is minimized
