Requirements

Breitung Township Schools (BTS) is evaluating a project to install broadband connectivity between their buildings and the new Technology Consortium Data Center location. Broadband connectivity shall be 10 gbps capable or better. Upgrading connectivity between our buildings will ensure the District can continue to lead the way in technological capabilities and offerings to our students, staff and community.

Scope of Work

Breitung Township Schools is entertaining bids for the following broadband connections:

- Kingsford Middle School Data Closet A (445 Hamilton Ave) to the Dickinson-Iron ISD Consortium Services Building (1295 Pyle Drive).
- Kingsford Middle School Data closet A (445 Hamilton Ave) to the Breitung Township Schools Administration Building (810 Pyle Drive)
- Woodland Elementary School Data Closet A (2000 Pyle Drive) to the Dickinson-Iron ISD Consortium Services Building (1295 Pyle Drive)

Vendor shall work with the Technology Consortium (TechCo) Directors to determine current and proposed network topology for this project.

Vendor for this job shall include the following in their bid:

- All costs associated with installation of each broadband run, which may include:
 - Patch Panels and labeling
 - o Termination, testing and certification of all connections
 - o Any patch cables necessary to complete connections to equipment
- As-built map documentation
- Vendor is responsible for obtaining all permits and allowances.
- Vendor is responsible for registering all broadband runs with MISSDIG.

A walkthrough is highly recommended. Please contact Derrek White to schedule a walkthrough of the buildings and proposed route. Building and potential route maps available upon request.

Awarding of this project is dependent upon eRate funding through USAC. Breitung Township Schools may choose to do all, some or none of the project.

Universal Service Fund (eRate):

The Breitung Township Public School District will apply for Universal Service Fund monies to cover approximately 70% of this project. This project is contingent on receiving eRate funding. Bidders must be an approved service provider and include their SPIN number with their bid. The USAC website can be found at http://www.usac.org/sl/.

Project Timing:

Vendors will be notified on or before February 14, 2025 if they are the successful bidder. The project start date is contingent on receiving our Funding Commitment Decision Letter (FCDL) from USAC and work cannot begin before July 1, 2025. Vendors shall include a contingency of price increases that will account for project delays.

Staging and Other factors:

Depending upon the total cost of the project and the overall budget, Breitung Township Public Schools may choose to decrease the number of units purchased. If that is the case, vendors shall be able to scale their proposal accordingly. Vendors will be selected based on their overall bid for the entire project.
