Foundation Aid Summary Plan – Address Student Performance and Need

1. Provide support for students who are not meeting or at risk of not meeting state learning standards:

- Expanded opportunities for summer school.
- Purchase content area supplies and materials and instructional technology tools to support struggling students and content area subscriptions for remediation.
- Allocations for additional teachers.
- Allocations for tutors, software and BOCES services previously charged to ARP grant.
- Instructional technology tools to support struggling learners, to provide for multiple pathways to learning and additional academic resources, applications, and devices.

2. Address student social-emotional health:

- Expanding community connections with an NYS approved mental health organization to streamline mental health services for our students.
- The district is hiring one full-time and one part-time social worker on our grants - the additional foundation aid allowed more funding for tutors, previously charged to the grant.

3. Provide enhanced resources to students with disabilities:

- Allocation for expansion of the Integrated Co-Teacher (ICT) model.
- Additional allocation for tutor staff, teaching aides, learning loss resources, direct reading and math academic intervention programs, and individual, target specific tutoring.
- Additional allocation for BOCES services to support our special education students.

Syosset Central School District - Foundation Aid Plan for 2022-23 Budget

The 2022-23 enacted New York State budget included a foundation aid increase of approximately \$4.5 million or 42% over the 2021-22 budgeted foundation aid amount. This increase is an effort to bring our district closer to our full foundation aid allocation, which is anticipated to occur in the 2023-24 school year. In accordance with Section D10 of the authorization for these funds, provided below is a statement of the proposed use of the funds to address student performance and need, specifically in the following areas: (1) providing supports for students who are not meeting, or at risk of not meeting, state learning standards in core academic subject; (2) Addressing student social-emotional health; and (3) Providing adequate resources to English language learners and students with disabilities.

Providing supports for students who are not meeting, or at risk of not meeting, state learning standards in core academic subjects. (Estimated at approximately \$2,406,000)

The additional foundation aid will enable the district to provide additional support to students who are not meeting and or at risk of not meeting the state learning standards in core academic subjects through a variety of means. The district budget includes:

- 1. Expanded opportunities for summer school.
- Allocations for content area supplies and materials to specifically address gaps and loss in the core areas.
- Allocations for costs previously charged to the ARP grant and have been
 incorporated into the budget including tutors, software and BOCES services aimed
 at closing instructional deficits, lost learning, and targeted, focused, academic
 interventions
- 4. Allocations for additional teachers.
- 5. Instructional technology tools to support struggling learners, to provide for multiple pathways to learning, and support struggling students with additional cognitive, developmental, and academic resources, applications, and devices for use at school and at home. (i.e., Chromebook device technology and applications, as well as content area subscriptions for remediation, support, enrichment, and reinforcement of state standards-based knowledge).]

(2) Addressing student social-emotional health. (Estimated at approximately \$70,000)

The additional foundation aid enabled the district to direct more resources to addressing student social-emotional health. The district budget includes:

- Expanding community connections with an NYS approved mental health clinic to expedite psychiatric evaluations for students in need and family/individual counseling services.
- The district was able to hire 1.5 new social workers on our grants as the additional foundation aid allowed the district to allocate more funds for tutors.

(3) Providing adequate resources to English language learners and students with disabilities.
(Estimated at approximately \$2,026,260)

The additional foundation aid will enable the district to provide additional resources for special education students. The district budget includes:

- An allocation for Integrated Co-Teachers (ICT) at the high school to continue to expand the ICT model in all grades to support students in English, mathematics, science and social studies.
- Additional allocations for tutor staff, teaching aides, learning loss resources, direct
 reading and math academic intervention programs, and individual, target specific
 tutoring.
- 3. Additional allocation for BOCES services to support our special education students.
- 4. Instructional technology tools to support struggling learners, to provide for multiple pathways to learning, and support struggling students with additional cognitive, developmental, and academic resources, applications, and devices for use at school and at home. (device) technology and applications, as well as content area subscriptions for remediation, support, enrichment, and reinforcement of state standards-based knowledge).
