



Departmental Budget Comparison 2016-2017




2016-2017 Three-Part Budget (Common Language)

Superintendent's Column

I'm pleased to announce the Board of Education adopted the recommended 2016-2017 budget unanimously at the Board meeting held on April 19th. Public voting on the 2016-2017 school budget, bus proposition and school board member election will be held on Tuesday, May 17th from 7 a.m. - 9 p.m. at the Orchard Park High School, located at 4040 Baker Road. Please use the Freeman Road entrance for your convenience

Drafting a budget that balances the needs of our students, improves the educational experience and stays within the parameters of the tax cap is no easy task. It requires long range planning, sound financial practices, research and many meetings by the administrative team. We have worked very hard over the last few months to present the Board a budget that meets the priorities of the district and maintains the integrity of the comprehensive K-12 program.

In December of 2015 our Board of Education and the administrative team developed goals and priorities for the 2016-17 school budget. These priorities included: increased safety and security, maintaining and growing our teacher coaching models in Math, Literacy and Technology, implementing a new 8 + lunch schedule in our High School and supporting our technology needs and initiatives. This budget accomplishes all of these goals.

As we move forward, we will continue to make our students our first priority. I am very thankful that Orchard Park has extraordinary teachers, support staff and administrators, and that we are supported by a community that values exceptional public education. We will continue to advocate for adequate state aid, high standards for our students and support for the local control of public education by our community. Please remember to come out and vote on Tuesday, May 17th any time from 7 a.m. - 9 p.m.

I thank you for your continued support.

The Orchard Park Central School District's proposed operating budget for the 2016-17 school year will:

- Improve school building access and control;
- ♦ Focus on a sustainable comprehensive K-12 program;
- Keep class sizes with current board guidelines; and
- ♦ Keep the tax levy increase within the tax cap requirements (which will result in a "Tax Freeze Rebate" for homeowners)

Cost Saving Initiatives *Almost \$4 million in annual savings*

- ♦ School Municipal Energy Consortium Program (SMEC), Energy Performance Contract & Cenergistic Program
- Telephone Service (Switch to BOCES in 2013)
- ♦ Self-Funded Health Insurance Program
- ♦ 2012 Retirement Incentive
- ♦ 2014 RFP for Worker's Comp & Liability Insurance Program

The safety of our students, staff and community members is always a top priority for the district. This budget allows us to improve safety while minimizing any negative impact on instruction.

- ♦ Focused Emergency Drills
- ♦ Single point of entry before during and after school hours
- Visitor ID software and hardware
- Upgrading our phone system
- ♦ Implement Transportation GPS software

Proposition 2 - Purchase and Financing of Vehicles

Voters will decide on the purchase of four (4) seventy - seven (77) passenger school buses at a maximum estimated cost of \$120,500 each, and four (4) universal wheelchair van-type buses at a maximum cost of \$75,500 each. The purchase, part of the District's long-range bus replacement schedule, will not add to the tax burden.

These eight buses, at a cost of no more than \$784,000, will be funded through state education reimbursements and contractual agreements. This proposition is similar to propositions passed over the last eleven years; and, if approved, will have no new tax impact on local taxpayers.

University at Buffalo's Visiting Teacher Program A Success in Orchard Park Schools

Our district leaders and staff are continually seeking innovative ways to enhance our students' educational experience while expanding students' cultural awareness to prepare them for our global society. To support these efforts, the Orchard Park Central School District has partnered with the Confucius Institute of the University of Buffalo. Through this partnership, Orchard Park is hosting two Chinese visiting teachers for the next 2-3

school years. The mission of the Confucius Institute is to encourage the study of Chinese language, promote a deeper understanding of contemporary China, and to develop an appreciation for Chinese history and culture.

In September we welcomed Haige Chang and Yanfang Xu to the Orchard Park Central School District. Ms. Chang and Ms. Xu spent the fall visiting each of our six schools becoming acclimated with American schools, Orchard Park, our staff, and our students. In November, Ms. Chang and Ms. Xu began visiting classrooms as guest speakers, presenting

on a variety of topics. In third grade our students study World Communities, and Ms. Chang and Ms. Xu enhanced this learning experience tremendously for our students. Many third grade classrooms celebrated the Chinese New Year with lessons taught by our visiting teachers. Recently during Mr. Helfman's sixth grade social studies unit on early China, our visiting teachers taught rich lessons integrating Chinese language, culture, social studies content and character education. During one particular lesson, students learned the philosophies of Confucius and his message of harmony, "Do not do unto others what you would not have them do unto you." Students gained an understanding of the philosophies of Confucius and how Confucius influenced Chinese culture. Ms. Chang and Ms. Xu introduced students to Chinese words and phrases, which they found very interesting. At our high school, among other engagements, students have been given the opportunity to participate in a Chinese language immersion

A Word From the President

On April 19th, the Board of Education unanimously adopted the 2016-2017 budget proposed by Superintendent McGarrity. The budget adheres to the criteria established by the Board at a budget work session in late January. It focuses on District safety and security, the newly-implemented coaching teaching model, and literacy. It also stays within the tax levy cap, ensures staffing to comply with current class-size guidelines, and, perhaps most importantly, maintains the comprehensive nature of the District's educational program.

The adopted budget represents months of building-level and district-level meetings and a tremendous effort by Superintendent McGarrity and the entire administrative team. We are fortunate to have a group of administrators so committed to both the stability and excellence of the District. The Board is hopeful that the community will support the budget on May 17th.

In addition to voting on the budget, the community will also be asked to approve a proposition for the

purchase of buses, identical to the bus-buying proposition that has been on the ballot for the past 11 years. The yearly purchasing of several buses permits the District to keep it's fleet in top condition, to keep bus maintenance costs low, and to maximize state aid for the purchase. The Board is hopeful that the community will approve the bus proposition as it has in the past.

Finally, the community will also elect two school board trustees on May $17^{\rm th}$.

Our District is fortunate that each year community members of different backgrounds, experiences and interests come forward to run for the school board. Effective school boards are critical to the success of school districts. There are widespread misconceptions about school board service, most of them based upon the notion that school board members are involved in the day-to-day operations of the district. We are not. Instead, the role of the school board is to oversee district operations and to focus on the "big picture." Some of the more important responsibilities within this oversight function are hiring and evaluating the Superintendent; adopting policies pertaining to all areas of District operations; and, establishing priorities and goals for the short- and long-term success and stability of the district. Yes, much of what school boards do may seem to the public like "rubber-stamping." However, recommendations to the Board should be approved if they align with the Board's policies, priorities and goals, and a good Superintendent will ensure that all recommendations are so aligned.

Before you cast your vote for school board trustees, consider these questions suggested by the New York State School Boards Association:

- 1. Does the candidate understand the role of the school board?
- 2. Is the candidate focused on a single issue or on a broad range of school district concerns?
- 3. Does the candidate's approach make it likely that he or she will be able to work effectively with the rest of the board?
- 4. Will the candidate enhance the mix of skills and backgrounds on the board and help represent the diversity of the community?
- 5. Does the candidate have the commitment to do what's right even in the face of strong opposition?

On behalf of the Board, I encourage everyone to become as informed as possible about the budget, the bus proposition and the school board candidates, and to make time on May 17th to vote. It's your duty and your privilege.

Contingent Budget Information

If the school budget is not approved by voters, the Board of Education has two options: put the budget up for a second vote in June or adopt a contingent budget. If a second vote is defeated a contingent budget would be adopted in the amount of \$93,638,442, and there would be no change to the tax levy. Further budget reductions would be required in the amount of \$994,191, which is the equivalent of approximately 13 full-time employees. Other area of reductions to close the gap could include, increased class sizes and reductions or elimination of non-mandated programs such as Kindergarten, athletics, co-curricular clubs and activities, and other non-mandated programs.
