### **General Themes**

Includes Parent, Student, and Staff Surveys and Participatory Action Research (IZI)



#### General Themes: Survey & IZI

 Distraction and Disruption: Cell phones are a major distraction in the classroom, negatively affecting students' focus, engagement, and overall academic performance

#### VERSUS

• Safety and Communications: Cell phones provide the ability for families to communicate when necessary. Students feel that having phones allows them to contact parents or authorities if needed.

#### General Themes: Survey & IZI

 Concerns of Students' well being: Cell phones can have negative effects on students' social development and mental health.

#### VERSUS

 Mental & Physical Health Support Tool: Cell phones and cell phone applications can function as a form of productive distraction, mental health support mechanism or coping strategy for managing anxiety. They also support specific health conditions including cochlear implants, monitoring glucose (blood sugar levels) and tracking insulin dosages.

#### General Themes: Survey & IZI

- The policy should look different for different student groups:
  - Elementary
  - Middle
  - High School

Create a balance between consistency in policy and variations in cell phone use and needs among different school-aged populations, managing special cases, accessibility needs, and family perspectives/experience/preferences.

# Statements of Consultation



### Statements of Consultation: Example

We believe [state the educational level] students [should/should not] have access to cell phones ...

- [Should/Should Not] have access during Instructional time
- [Should/Should Not] have access before and after school
- [Should/Should Not] have access while riding on a bus
- [Should/Should Not] have access during Breakfast/Lunch

### Shared Community Responsibility

- Emphasis on <u>shared community responsibility</u> for sustaining any eventual policy and implementation with roles for
  - Parents and caregivers,
  - Teachers and school administrators,
  - PTO members
  - Students
- Particular concerns about not overburdening the teachers with the enforcement of the cell phone policy
- Some interest in developing parent and youth support mechanisms and community education offerings supportive of the eventual policy and its justification.
