The student will also be placed on Board probation for the remainder of the school year. The motion passed 4-0-1 (Brown abstained).
- 10.030.25 – WAHS – Infraction: Major Disruption (020) – A motion was made by Daniels, seconded by Mundy, to have the student placed at Turning Point Academy for a minimum stay of 45 days. The student will also be placed on Board probation for the remainder of the school year. The motion passed unanimously.
- 10.031.25 – WAHS – Infraction: Aggravated Assault/Major Disruption/Intimidation (510/020/650) – A motion was made by Daniels, seconded by Brown, to have the student expelled for the remainder of the school year. The motion passed unanimously.
