5.1.2 WCUUSD Capital Improvement Plan

It's a five-year plan (FY23-FY27). Appropriates more funds into capital projects for buildings, roofs, parking lots, doors, windows, boiler upgrades, etc. This plan is similar to what we've done. We don't have a formal written plan but a good resource we can build into our Facility Operating Plan. Our five-year operating plan is similar but a different document. This one seems to be a little bit of both. Mr. Evans believes it will be a snapshot of where we are now with some history. Mr. Cecchinelli - past, present, and future planning in two documents

6.1 Stormwater Plan Update (BC, BT, SHS)

SHS - Nearing completion of mandate, 85% completion. Things to do in the spring - Drainage needs to be adjusted downstream, currently upstream, seed grassy areas, finish grading asphalt on Crimson Tide Drive, and return to a grassy surface. The state of VT funds 90% of the project, and the district is responsible for 10%.
