Dear Mr. Deka:

This correspondence is in response to your Freedom of Information Act Request received by District 47 on October 24, 2016, as well as your clarifying email stating your request is for a 30-day time frame from the date of receipt. You requested:

1. Records for all bus drivers employed for TJA that have successfully attend or passed any curriculum that stems from Illinois state law and administered by Illinois State Curriculum for School Bus Drivers or similar body administering school bus driver training.
 - See attached document
2. Any and all written procedures that deal specifically with incidents that happen on District #47 busses.
 - District 47 does not possess records containing the information you are requesting. The FOIA does not require a public body to answer questions, prepare records that do not currently exist, nor is the FOIA intended to compel public bodies to interpret or advise requesters as to the meaning or significance of public records. 5 ILCS 140/1, 5 ILCS 140/3.3. The FOIA only requires a public body to provide records that are in its possession at the time of the request and that are not exempt from disclosure.
3. To the extent you consider this response a denial to your request; you have the right to have the denial reviewed by the Public Access Counselor (PAC) at the Office of the Illinois Attorney General. 5 ILCS 140/9.5(a). You can file your Request for Review with the PAC by writing to: Public Access Counselor, Office of the Attorney General, 500 South 2nd Street Springfield, Illinois 62706, Fax: 217-782-1396, E-mail: publicaccess@atg.state.il.us, Phone: 312-814-5526. If you choose to file a Request for Review with the PAC, you must do so within 60 calendar days after the date of the denial letter. 5 ILCS 140/9.5(a). Please note that you must include a copy of your original request

for documents and the denial letter when filing a Request for Review with the PAC. You also have the right to seek judicial review of your denial by filing a lawsuit in the State circuit court. 5 ILCS 140/11.

This information serves as fulfillment of obligation to your request. I would appreciate if you would acknowledge receipt of this FOIA as well as being able to successfully view all documents.
