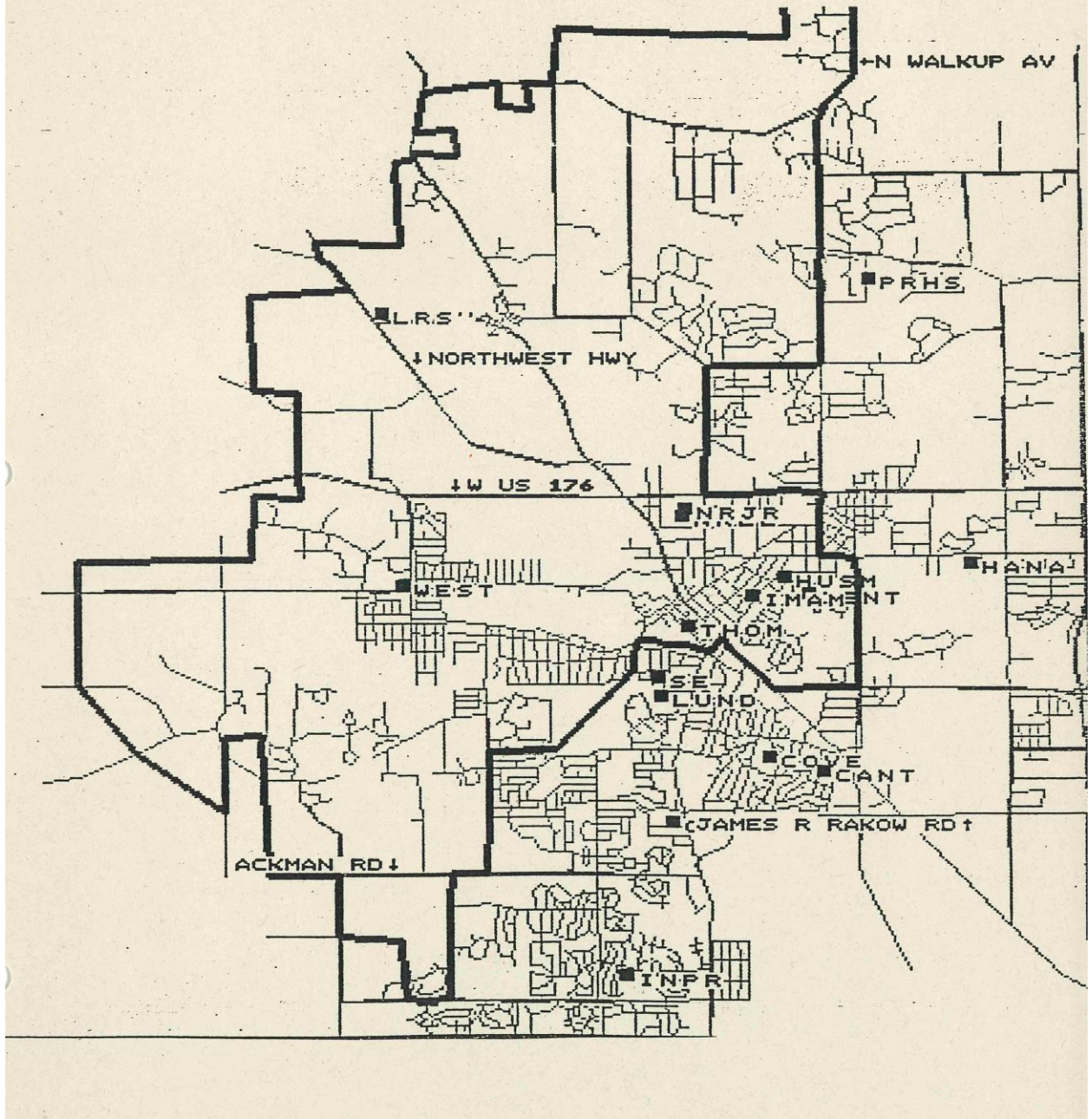
# NEW MIDDLE SCHOOL BOUNDARIES



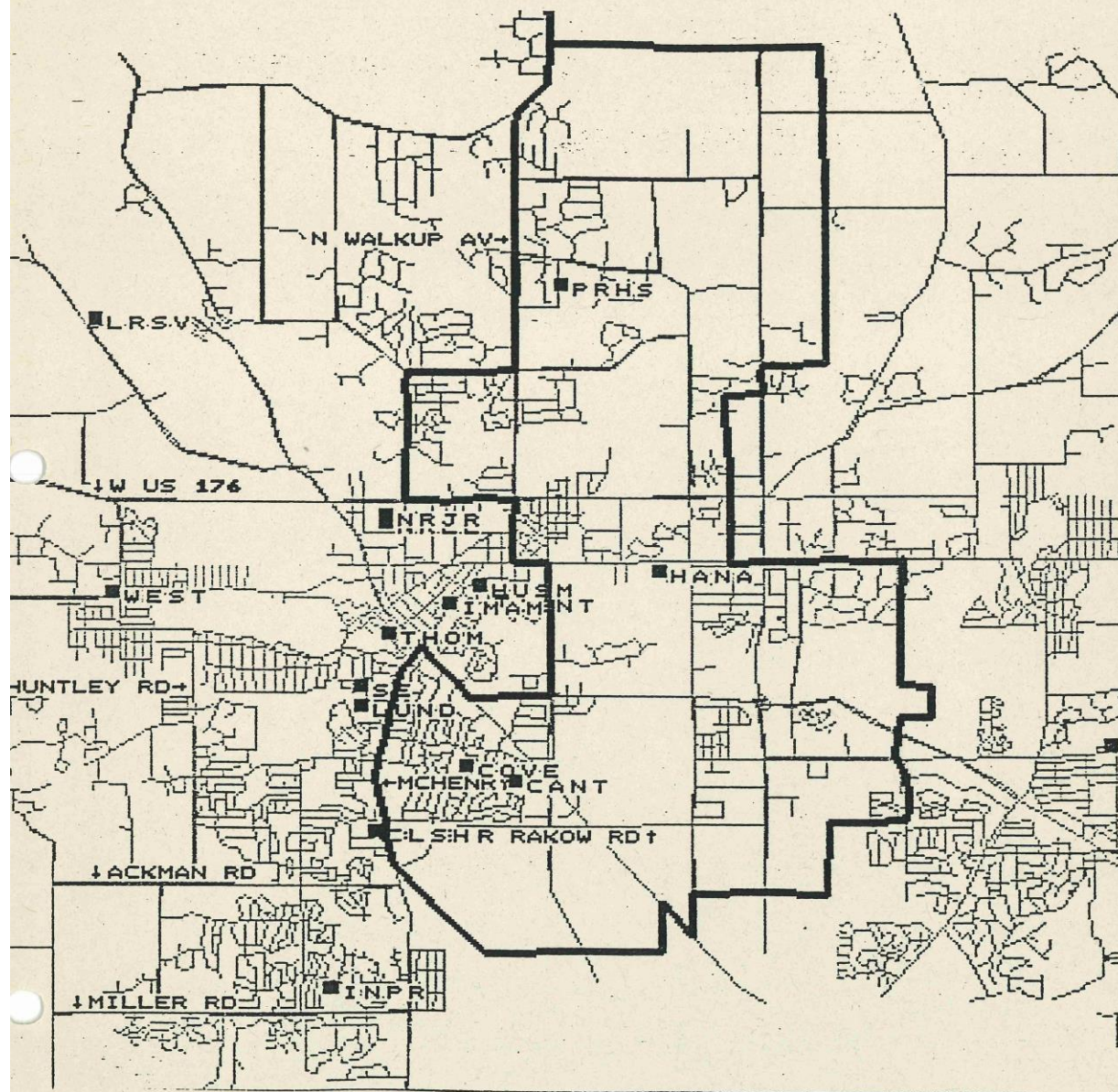
# LUNDAHL MIDDLE SCHOOL



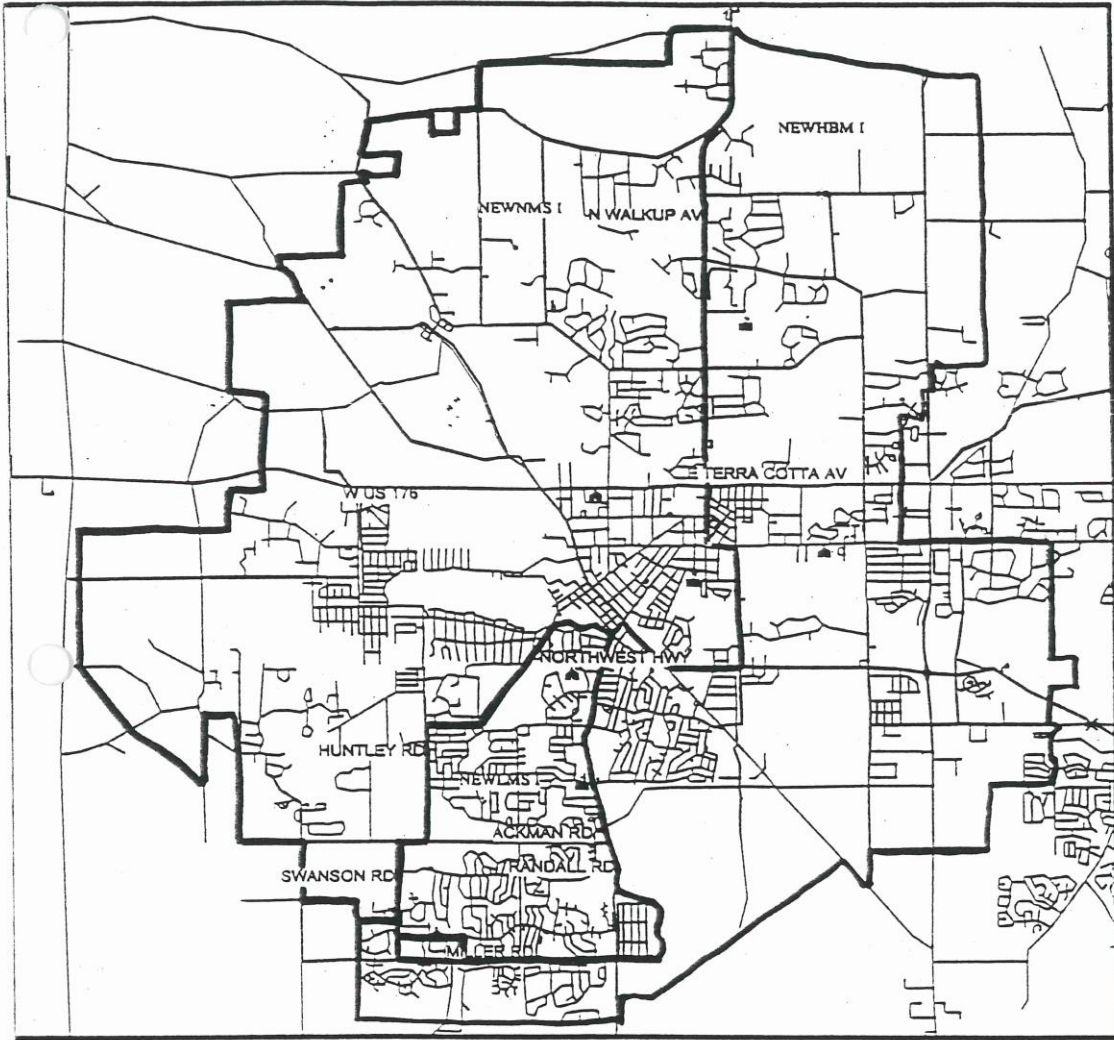

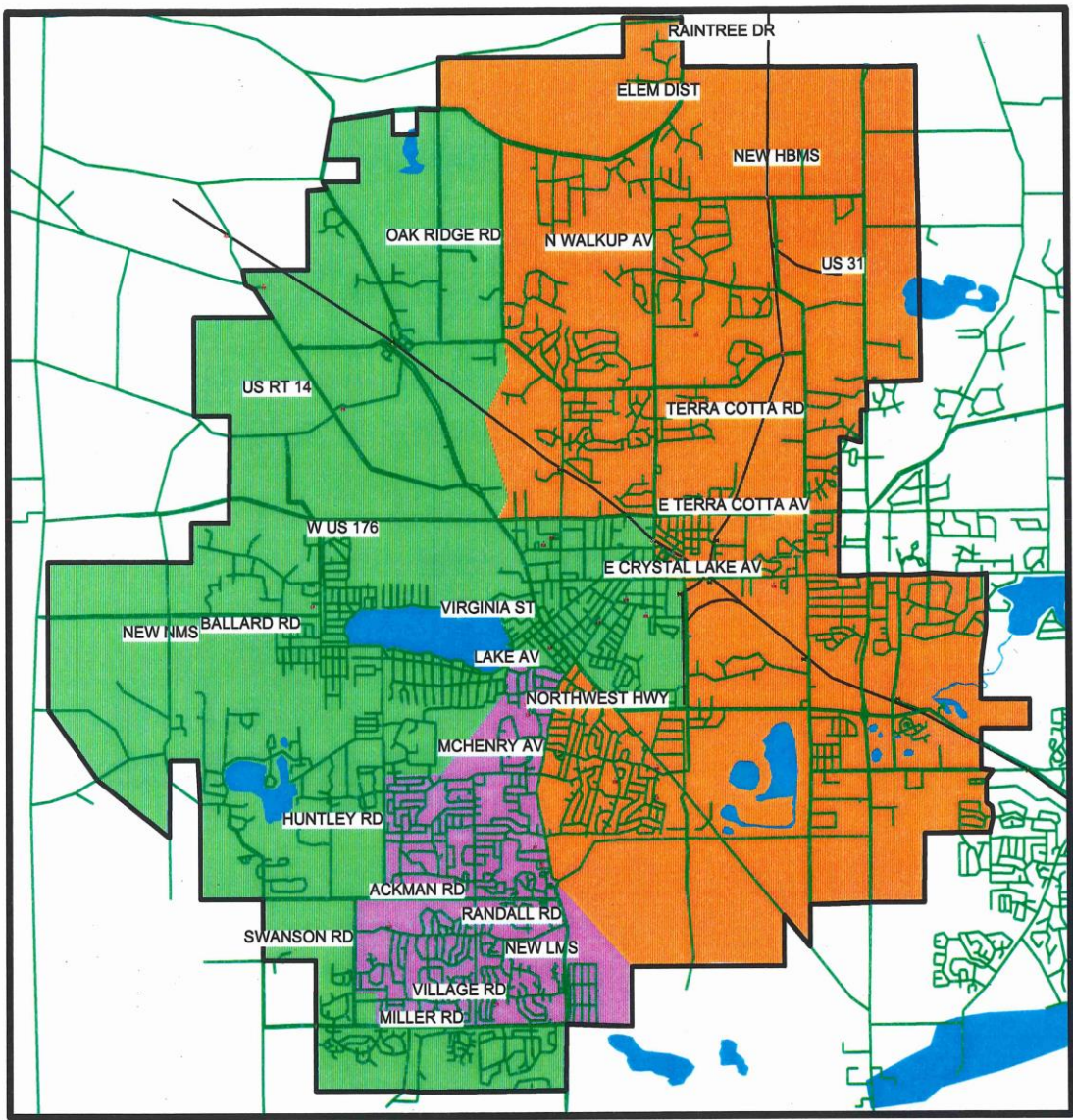

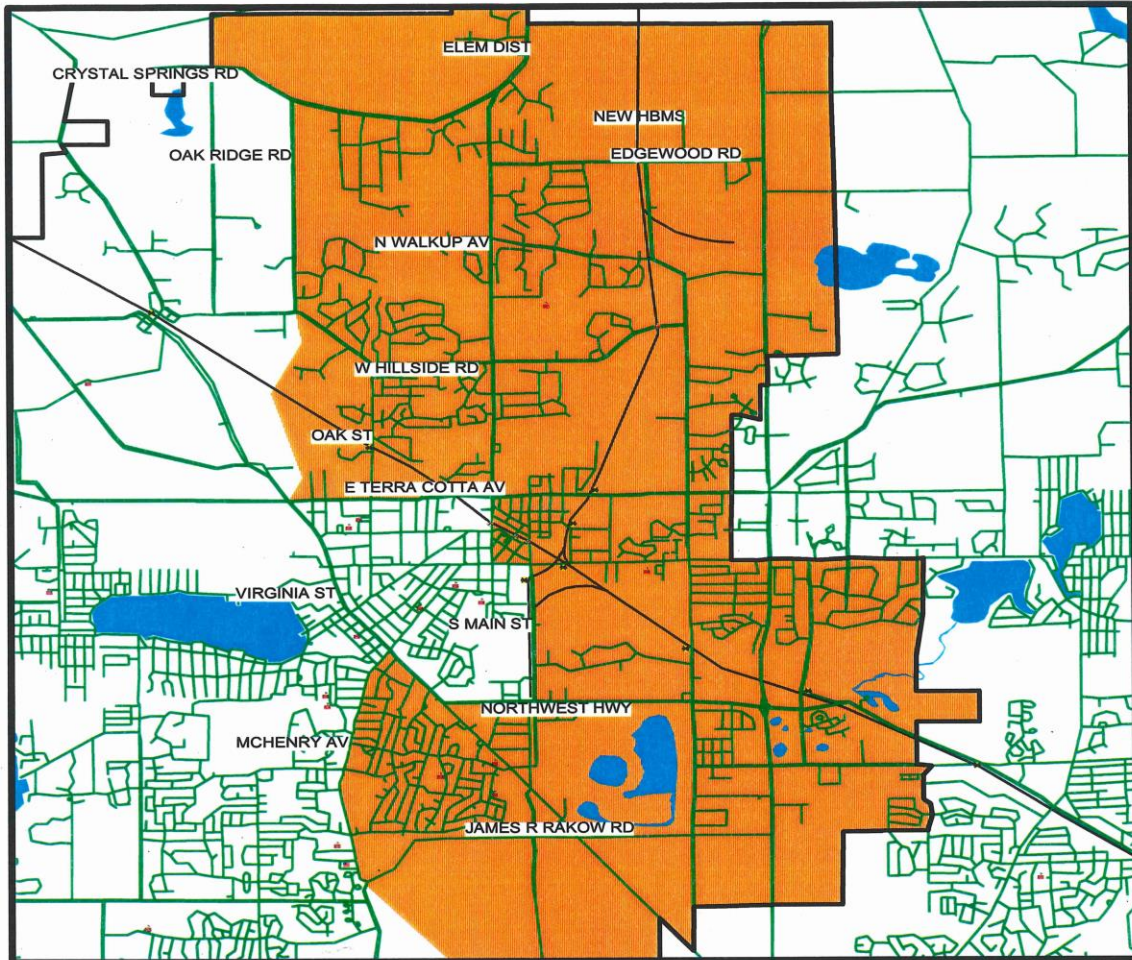

Effective 2000-01

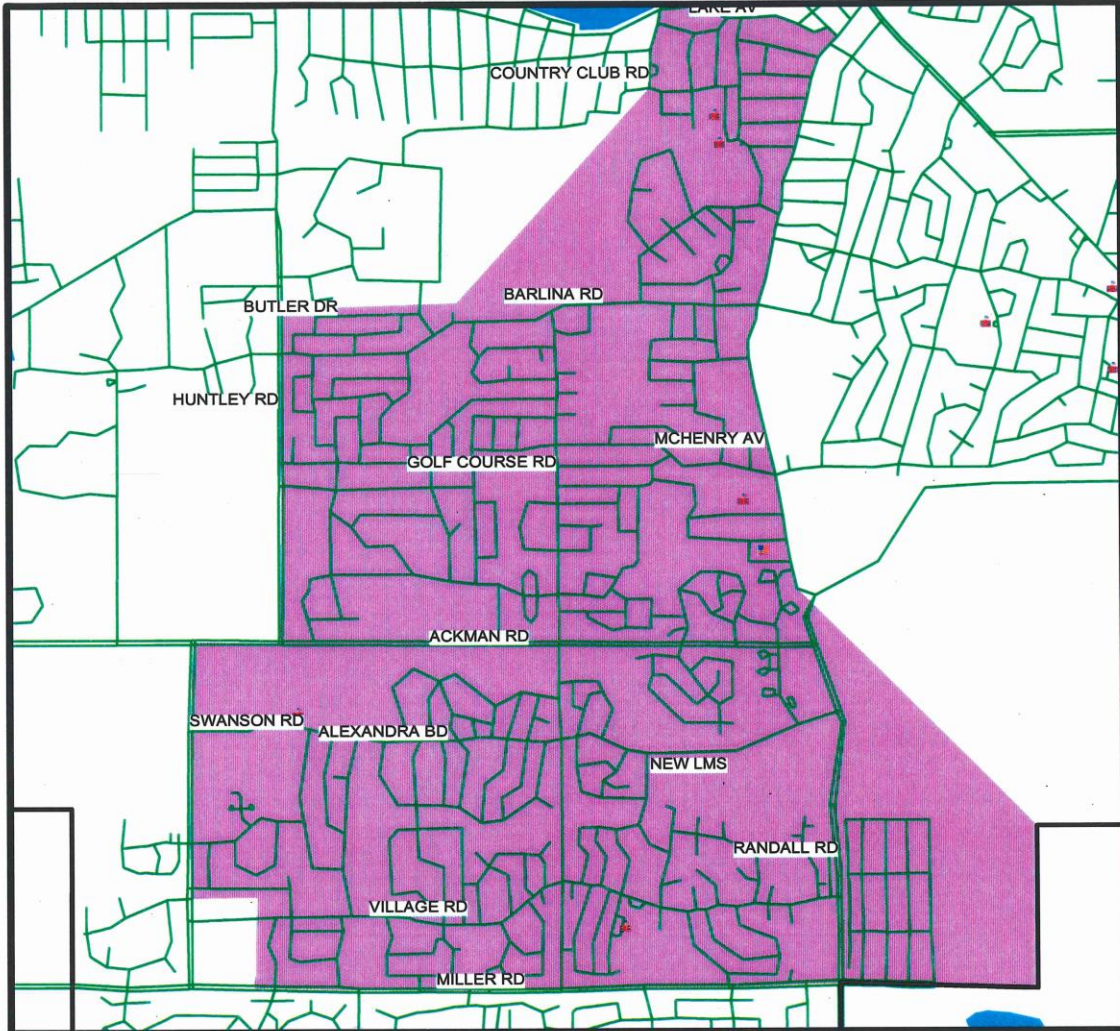

Effective 2000-01**

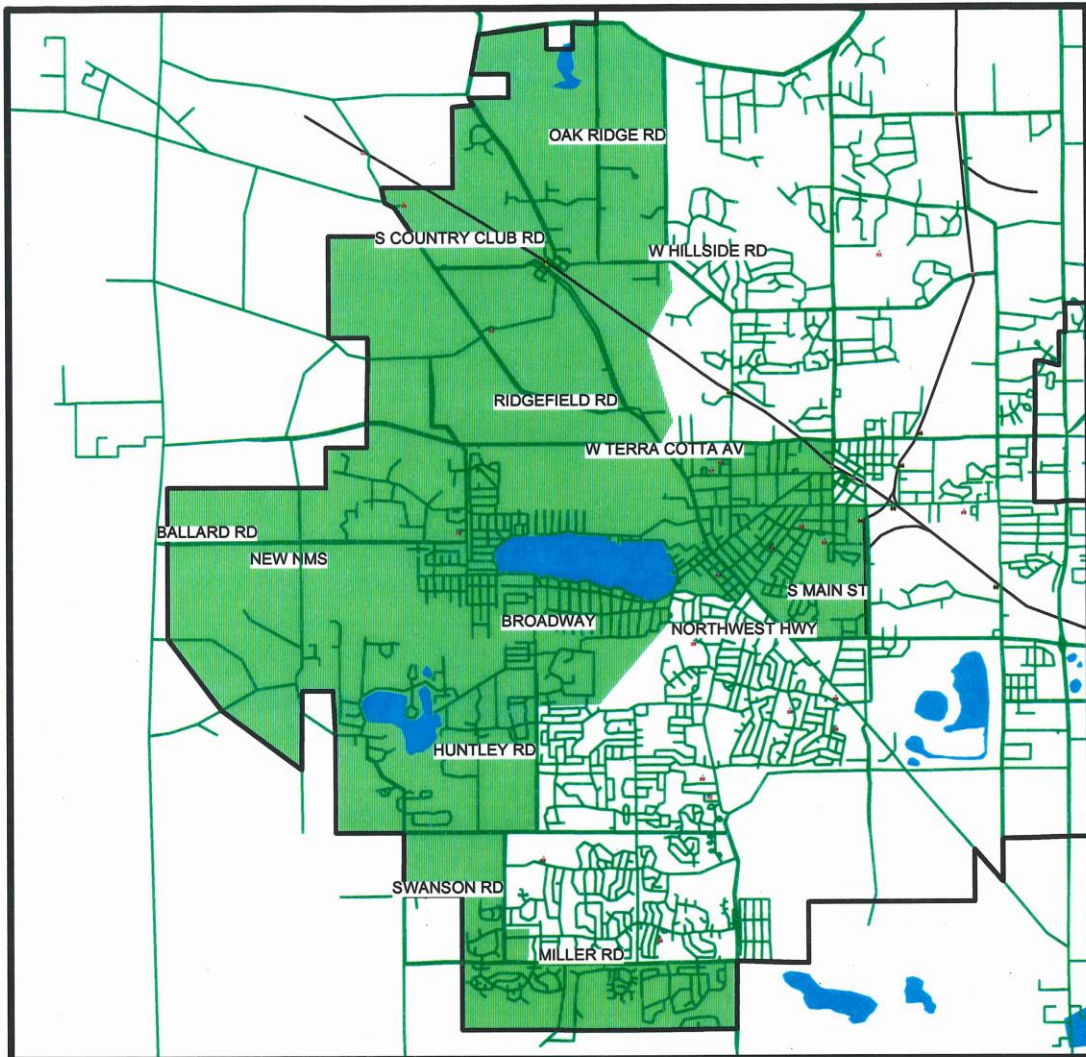

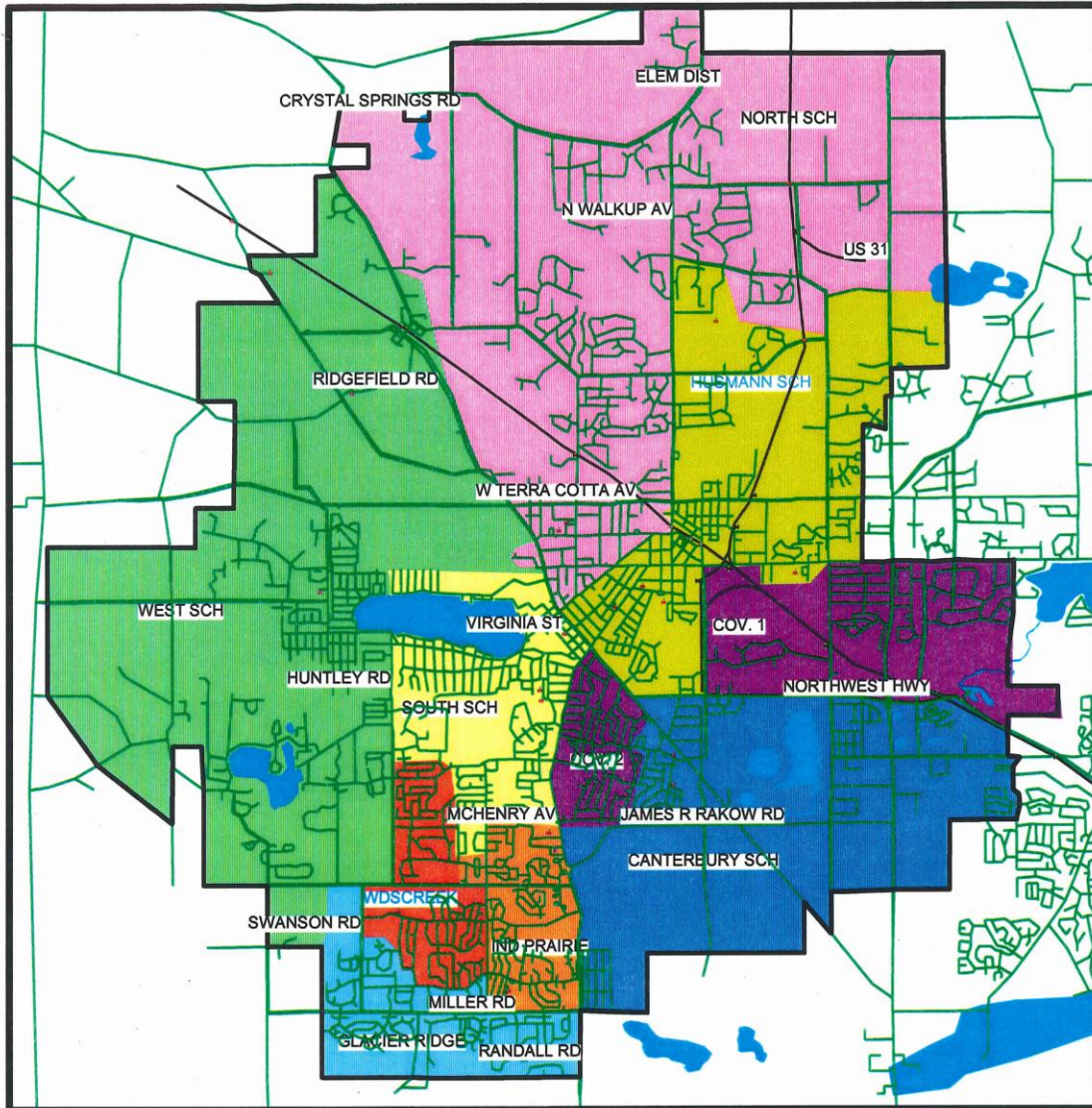
