SCHOOL-BASED TAX INCREASE:

There are three factors that contributed to this year's increase in the school-based portion of the tax bill:

1. The approved referendum

• The tax impact from the approved referendum is listed above in your tax bill.

2. Fair market property value increases

• If a property's fair market value increases, the school-based portion of the taxes increases proportionately. Fair market property value increases are not related to the passed referendum. You can determine your increase by comparing your fair market value from last year's tax bill to the fair market value listed on your current bill.

3. Non-referendum-related school increases

• A smaller portion of the tax increase is due to an increase in private school vouchers and the amount of state aid received by the district.
