The District plans to invest in a psychologist, speech pathologist, social workers, special education teacher, after school intervention, summer school intervention, miscellaneous special education curriculum and interventions, and classroom sound systems to assist our students with disabilities as they return to the classroom. The intention is to ensure that our students disproportionately impacted by the COVID-19 pandemic receive the same support as our general education students, and to address any learning loss, evaluate any need, and properly support the needs to ensure success. We feel these staff investments are in their best interest to combat the complications that have developed due to the COVID-19 pandemic.

## Please describe how the LEA will use the funds it reserves under section 2001(e)(1) of the ARP Act (see below) to address the academic impact of lost instructional time through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year:

The District intends to purchase a variety of special education curriculum, as well as invest in new staff. All of these investments will target those students with disabilities who have been disproportionately impacted by the COVID-19 pandemic and will support their recovery of learning loss.

Our special education teacher, psychologist, speech pathologist, and social workers will be instrumental in addressing student learning loss by identifying, working with, and supporting special education students with their academic and social-emotional needs.

We will have facilitate both after-school and summer enrichment programs. This will include teachers providing education, admins to plan and oversee the program as a whole, supplies/snacks for the students, and transportation for the summer program.

New sound systems will be installed to assist our students with hearing disabilities.

## Please describe how the LEA will spend its remaining ARP ESSER funds consistent with section 2001(e)(2) of the ARP Act.

Funding will be utilized to support the acquisition of curriculum, with an emphasis on learning recovery in the areas of mathematics and content area literacy. Additionally, we will invest in math coaches to address learning loss both in the summer and after-school. Funding will also be directed toward mental health support for students by funding school social workers, a psychologist, and mental health resources that can be implemented at school, as well as at home.
