On Thursday, April 25, 2024, a bid was opened for the Addition of Five (5) Pre-K and T-K Classroom Buildings at Westpark Elementary School. The following are the results of the bid opening for the bid scope:

American Modular Systems, Inc. (AMS) – \$5,232,000.00

This was the only contractor that attended the mandatory job walk.

The Uniform Public Construction Cost Accounting Act (the "Act") adopted on September 16, 2008 (BSA-23-08/09, Resolution No. 15-2008/09) provides an alternative method for public agencies to obtain bids and perform public projects. For projects of more than \$200,000, formal bidding procedures will be followed (PCC 22032(c)). If no bids are received, the District may negotiate a contract or use their own workforce. The award of contract and use of own workforce "force account" is still subject to approval by the Board of Trustees. On March 6, 2024, the Board of Trustees Approved Action Item IX.I, "Approve to COMMENCE FORMAL BIDDING for Addition of Five (5) Pre-K and T-K Classroom Buildings at Westpark Elementary School".

It is recommended that the Board of Trustees approve the contract to the lowest and only responsive bidder, American Modular Systems, Inc. (AMS).
