

**Monroe-Gregg Board of School Trustees  
Minutes of the Special Meeting  
Administration Office  
November 6, 2024**

The regular meeting of the Monroe-Gregg Board of School Trustees began with the Pledge of Allegiance.

**CALL TO ORDER**

The meeting was called to order by Board President, Mr. Jack Elliott at 5:30 P.M. in the Administration Office. Board members in attendance included Mr. Brock Sears, Mrs. Celina Clements, Mr. Tom Kennedy, and Mr. Ky Kizzee. Superintendent, Mr. Trent Provo and Corporation Treasurer, Moriah Crane were present. In addition, MGTA representatives, Mrs. Casey Honkomp and Mrs. Julie Dimmack were present.

**PUBLIC COMMENTS**

There were no public comments.

**CONSIDERATION OF THE TENTATIVE MASTER TEACHER CONTRACT**

Mr. Provo and Mrs. Honkomp highlighted some of the new items:

- Teachers took a step up on the salary scale of \$1,000. Teachers at the top of the scale receive a \$1,000 stipend.
- Increase to corporation contribution to all insurance categories. (2%-10%)
- Corporation contribution into Health Savings Accounts will increase to \$1,000 (previously was \$900).
- Increase buy-back of accumulated leave days over 120 to \$100 per day (previously was \$45).
- Added a few ECA positions and/or increased pay to make things equal between girls' and boys' athletics. Restructured the Event Coordinator positions to create a middle school athletic coordinator.
- Appendix C will be deleted from the contract once the last teacher covered by the 2005-2006 pension bond buyout has retired. Appendix D was deleted and several items were deleted from Appendix E.
- Included language on supplemental pay for teachers that cover rooms as substitutes or take students into their classroom to cover. Specials teachers at all levels will receive \$25 per class period when acting as a sub. Elementary teachers will receive \$50 per day if they have students added to their classroom for a full day. Pay will be prorated if less than a full day.

There were no public comments in the hearing. No Board action was required.

There were no public comments.


**ADJOURNMENT**
