Fast Facts: Recap Meeting #2

- 97% of BISD local revenue comes from Foundation School Program (local property tax and state aid).
- BISD facility rental revenues are above the average of our comparison districts.
- BISD athletic revenues are above the average of our comparison districts.
- BISD investment revenue is comparable to most of our comparison districts.
- BISD is not an open-enrollment district.



Local Revenue & Golden Pennies

Property Tax Rate in Boerne ISD - M&O

Tier 1

MCR: Maximum Compressed Rate

Controlled by Texas
Education Agency

- Currently \$0.6169 per \$100 of assessed value
- Compressed (lowered) annually since 2019

Tier 2

Golden Pennies

Total of 8 pennies with guaranteed yield

Tier 2

Copper Pennies

Total of 9 pennies

- First 5 pennies authorized by Board
- Second 3 pennies not utilized
- Would require voter approval

- Authorized by voter approval
- Subject to recapture
- BISD has not utilized

FAST FACTS: Golden Pennies

Based on 2024–25 rates, three additional golden pennies ...

- \$0.01 tax rate yields about \$1.1M in collections
- Guaranteed yield (additional state aid) would bring \$533K per penny
- Three golden pennies would provide over \$4.9M in revenue
- One penny for the average BISD taxpayer is \$50.64

Fast Facts: Campus Budgets (\$1.3M)

- Principals receive a campus budget on July 1 of each year
- Allocation based on per student anticipated enrollment
 - Elementary \$90
 - Middle School \$115
 - High School \$130
- Can be re-allocated through the year to anything non-payroll.
 - Classroom supplies
 - Office supplies
 - Supplemental pay
 - Special program fees (For example: Relationship Centered Learning)
 - Professional learning (conferences, books, etc)



Fast Facts: Child Nutrition Budget

- Students who qualify for FRL drive a large portion of the Child Nutrition budget.
- School Boards adopt a Child Nutrition budget annually.
- Revenue is driven by the total number of meals served.
 - o 2022-23: 629,865 meals served
 - o 2023-24: 697,465 meals served
- Meal prices for 2024-2025
 - o PK 5 lunch: \$3.40
 - Grades 6-12 lunch: \$3.65
- BISD is strategic in our efforts to identify families in need of assistance.



Fast Facts: Weighted Average Daily Attendance

- Weighted Average Daily Attendance (WADA)
 - The state provides additional funding for ISDs based on the number of special needs students enrolled
- Foundation School Program, Tier II: Enrichment Programming
- BISD receives WADA for:
 - o Bilingual/Dual Language
 - Gifted and Talented
 - o Early Childhood and Special Education
 - CTE
 - Free & Reduced Lunch
- BISD strategies for maximizing WADA
 - Ensure accurate data reporting
 - Accurately screening and identifying students (GT, SPED, Emergent Bilingual)
 - Maximizing Enrollment (CTE, Emergent Bilingual)

Fast Facts: CTE Comparisons

- BISD offers 18 CTE programs of study across 11 career clusters for students. This is more than most districts our size.
- In 2021-22, BISD had the 2nd highest percentage out of our comparison districts of students that qualified as College, Career of Military Ready (CCMR). Since then our CCMR percentage has only increased.
- BISD offers two P-Tech pathways. This is more than most districts our size.
- BISD offers high school credit CTE courses to our middle school students. We receive weighted funding for these 7th and 8th grade students as well.
