<b>*\$1800.00/month</b>

**\*Please note the 2025-2026 tuition rates may increase as a result of pending State, County, and/or District related regulations. If an increase is deemed necessary, we will notify enrolled/waitlisted families with regard to the tuition adjustment.**

- The annual tuition is divided into 11 equal monthly payments (August-June)
- Payments are due on the 1<sup>st</sup> of each month and delinquent after the 5<sup>th</sup> (late fee applied)
- New families and siblings not currently enrolled will pay a one-time non-refundable application fee of \$150
- A **non-refundable** deposit equal to one month’s tuition confirms enrollment acceptance and is applied to the **first** month of attendance
- Fees are not refundable, prorated, adjusted or reimbursed for any non-school day,, absences), unusual circumstances, or emergency closures

Fees regarding enrollment or withdrawal after the school year begins

Enrolling or Withdrawing in August	Non-Refundable deposit equal to one month’s tuition is applied
Enrolling in September-May & your start day is	1 <sup>st</sup> – 15 <sup>th</sup> charged a full monthly fee 16 <sup>th</sup> – end of month charged half monthly fee
Withdrawing in September-May	If written notification is provided before the current month and the last day is at the end of the current month then no additional payments. If written notification is provided before the 20 <sup>th</sup> of the current month and the last day in the month is, 1 <sup>st</sup> -15 <sup>th</sup> charges half the monthly fee. If your last day in the next month is 16 <sup>th</sup> until the end of the month, charge the full monthly fee. If written notification is provided after the 20 <sup>th</sup> of the current month then full monthly fee s charged for the next month.
