DISCUSSION

SPECIAL COUNSEL TO THE BOARD OF EDUCATION - Ms. Baker

Ms. Baker read the following statement regarding the appointment of Special Counsel to the Board of Education:

As set forth in the Superintendent's employment contract, there is a reopener provision that is triggered this May when the state-mandated salary cap changes. At the time the contract was negotiated, the District employed an in house attorney as District Counsel and Mr. Sayovitz of Schenck Price acted as the Board's special counsel with respect to the negotiation of that employment contract.

Now that Mr. Sayovitz is working as District Counsel and in district part time during the week as part of the administrative team that reports to the Superintendent, it is appropriate, and the best practice, for the Board to retain special counsel to advise the Board in matters related to the superintendent's employment to avoid any appearance of a conflict of interest.
