Mr. Eastman declared the minutes of the Executive and Public Sessions of August 24, 2015 and Public Special Session on August 28, 2015 approved as presented.

AMENDMENT TO THE SUPERINTENDENT'S CONTRACT

Mrs. Daugherty explained that the amendment to the Superintendent's contract is to provide health benefits which are the same benefits offered to all staff.

HEARING OF INDIVIDUALS AND DELEGATIONS (SUPERINTENDENT'S CONTRACT) - None.

SUPERINTENDENT'S MONTHLY UPDATE

Goal 1 Student Learning:

- The first day of school opened smoothly, thanks to the dedicated efforts of teachers, administrators and the incredible helpfulness of parent volunteers, and the great attitude of students.
- Classes for the new Montrose Early Childhood Center have started, although not yet at the Montrose building, due to delays caused by PSE&G. The classes are meeting in various elementary school buildings until it is possible to move into their permanent home
- Meetings have taken place with the new Regional Achievement Center (RAC) team members to discuss the status of the three focus schools, including the decision making process for next year, state assessment outcomes, feedback from the Regional Achievement Center field teams and other qualitative indicators of sustained improvement. Focus School Principals will attend a School Improvement Plan Management System meeting to discuss the expectations for the school year including Cycle Reviews, Data collection/SIP Management System/End of Cycle Dashboard, Climate & Culture Surveys, and walkthroughs.
- This year we are offering 21 Advanced Placement (AP) courses, divided into 44 distinct sections
- Various sections of mathematics laboratory classes have been developed to assist students with supplemental instruction in Algebra 1, Geometry, and Algebra 2
- The Board of Education will conduct the first reading of a proposed Access and Equity Policy tonight. This policy would allow the district to move significantly forward in our efforts to be an exemplary suburban school system.

Goal 2 Professional Staff:

- The school year began with convocation for all staff when two distinct ideas with the staff: the need as a district to focus on the fundamentals, and the need as a district to pursue innovation
- Every teacher in the South Orange Maplewood School District was engaged in targeted professional development for their subject, department and age group. Many thanks to the supervisors and teachers who led workshops to help us more effectively serve our students in the coming year.

Goal 3 Engagement and Outreach:

- A pilot communications initiative, Let's Talk!, was launched on September 11th, and is on the agenda for discussion tonight. Since its introduction, we have received more than 70 dialogues from parents, staff, students and other community members.
- The Superintendent's listening tour continues with a Meet & Greet and two town halls, one for elementary families and one for secondary families.

Goal 4 Resource Management:

- Information sessions on the enrollment process for health benefits have been taking place over the past two weeks and were very well attended. Staff are reminded to submit their enrollment forms or waiver forms to Human Resources by the end of this week.
- A huge thank you to all of the PTA's and H.S.A.'s, and the school communities, for their ongoing financial support. A number of donations were made at the end of last year for project installations over the summer. Most of these installations are nearing completion.

Dr. Ramos introduced a framework for strategic planning a service delivery model that puts students at the top and has staff supporting upward rather than the standard top-down management models. Dr. Ramos also described the planned Education Summit and asked that community members submit topics that they think will make good discussion.

BOARD PRESIDENT'S REPORT

Mr. Eastman spoke about the Board of Education/Senior Leadership Team (SLT) KIVA session and the KIVA process. Mr. Eastman reminded the community that policy-making is one of the key responsibilities of the Board of Education and that there is a significant policy on for discussion tonight, the Access and Equity policy on for first reading.

DICUSSION

LET'S TALK COMMUNICATIONS PILOT - Suhauil Farooqui, Founder

Founder of Let's Talk, Suhauil Farooqui explained the Let's Talk program and the background on the development of Let's Talk. Mr. Farooqui described how the program works as well as the type of reporting available from the data gathered with the software

The Let's Talk software went live in the South Orange and Maplewood School District on September 11 and about 70 contacts have been made so far. The Board will be informed about number of communications, trending topics, and timeliness of responses.

Board member discussion included positive responses to the types of data that can be reported, reiterated that communication is an area needing attention, and questions about what other districts are using the tool and the type of feedback they are receiving.

HARASSMENT INTIMIDATION AND BULLYING SELF-ASSESSMENT REPORT - Mr. Stern

Mr. Stern spoke about the history of the self-assessment report and the associated reporting requirements. Mr. Stern presented a Powerpoint presentation indicating he self-assessment scores for each of the district schools. [Presentation on file in Board Secretary's office]

A brief board discussion included the following:

- How are staff being trained to identify Harassment, Intimidation and Bullying incidents?
- Could confusion about reporting requirements lead to under-reporting?
- Is there anything beyond the self-assessment tool that is being used to gauge the District's success in addressing harassment, intimidation and bullying?
- How are incidents that are not Harassment, Intimidation and Bullying being addressed?

SUMMER SCHOOLS PROGRAM UPDATE - Mrs. Grierson

Mrs. Grierson presented a Powerpoint presentation showing 725 students attended summer school in a variety of programs including the Cougar Prep program, summer step-up classes, academic advancement courses, as well as academic support programs [presentation on file in board secretary's office].

Board member discussion included the following comments:

- The financial presentation suggests lower spending at the middle schools. Have we received feedback from the middle school principals if there is enough support at this level?
- Do the high enrollment numbers for credit recovery reflect that all these students failed courses?
- Are we analyzing who is in these courses to confirm that the same students are not returning for credit recovery each year?
- What percentage of students needing this support are taking advantage of the summer courses?

2016-2017 SCHOOL CALENDAR - Dr. Ramos

Dr. Ramos discussed the proposed 2016-17 calendar and explained why decisions were made on the calendar. Feedback from the bargaining units and parent teacher organizations was obtained and incorporated into the calendar.

Board member discussion included the possibility of coordinating our calendar with other districts which may be helpful to teachers who work in the

district but have children in school in other districts. Board members also asked about the possibility of holding parent conferences in less disruptive months since there are so many days off in November.

BUDGET ANALYSIS UPDATE - Mrs. Lawson-Muhammad

Mrs. Lawson-Muhammad indicated that the Finance, Facilities and Technology committee discussed the need for some analyses as has been done in the past such as an analysis on Special Education Out of District placements. The committee has suggested rethinking how these analyses are done and if they inform the budget or just provide additional information on various topics. A different approach may be more in-depth reviews of spending. The recommendation was to allow the Education Summit to take place and let those discussions help inform the budget development.

POLICY 5755.1 ACCESS AND EQUITY - 1ST READING - Mr. Stern

Mr. Stern reviewed the policy and proposed language.

Board member discussion indicated support for the policy. Comments included recognition that the policy shapes direction but need to be sure that students are supported in taking advantage of what the policy offers. It was suggested that the policy on academic placement needs to be updated to comport with this new policy.

COMMITTEE REPORTS

NEGOTIATIONS - Mrs. Daugherty

South Orange Maplewood Education Association (SOMEA) and the Board have reached a tentative agreement and are in the process of developing mutually agreeable salary guides.

POLICY AND MONITORING - Ms. Baker

The committee discussed Board goal development and the strategic plan presented by Dr. Ramos, as well as the Office of Civil Rights (OCR) agreement, the access policy and 504 policy development. Ms. Smith will work with Mr. Stern on the development recommendations regarding coaching and athletics.

EQUITY AND EXCELLENCE - Mr. Bennett

The committee discussed the access policy and how it may be implemented. The committee also discussed the district goals including stabilizing special

education referrals, the success of the reading program, and aligning Board goals with the merit goals in Dr. Ramos' contract.

FINANCE, FACILITIES, AND TECHNOLOGY - Mrs. Lawson-Muhammad

The committee discussed the budget analyses and other topics already covered in the agenda discussions.

COMMUNITY ENGAGEMENT AND OUTREACH - Mrs. Wright

The committee hosted the Superintendent's Meet and Greet in lieu of a meeting this month.
