2015-16 Preliminary Budget - Mrs. Schneider

Mrs. Schneider provided a Powerpoint presentation that included the following information:

- Review of the Budget Development Process
- Tax Levy Cap Adjustments and Banked Cap
- Estimated Tax Impact at 2% Operating Budget Increase
- Revenues Proposed 2015-16 Budget
- Budget Considerations in the Proposed Budget
- Expense Adjustments and Reductions
- Expenses Proposed 2015-16 Budget
- Expense Adjustments and Reductions
- Estimated Tax Impact with \$330,000 Tax Cap Adjustment

Presentation was followed by discussion among Board members including the following topics:

- Clarification on the use of capital reserve
- Questions about reference reorganization of administration

- Concerns about continuous impact on elementary schools where we should be making the first actions to address the achievement gap
- Disappointed about reduction of Elementary World Language
- Physical education credit for High School sports
- Montrose can be revenue if we bring Out of District student back in District
- International Baccalaureate program can be cut to save other programs
- Consider sacred cows such as Marshall/Jefferson pairing
- Status of the evaluation of health benefit alternatives
- Look at cutting administrators and get more staff in the classroom
- Proposed pension reform and impact on the District budget
- Discussion about tax level - budgeting for 2% at operating budget, or using \$330,000 of tax adjustment for a 2% increase including debt service.
- Discussion regarding having the auditor return to discuss the budget and use of funds

HEARING OF INDIVIDUALS AND DELEGATIONS

Dionne Williams Maplewood	Board should acknowledge that the funds are dependent on taxpayers who are heavily burdened. Also commented on funds that should have been returned but the Board did not act.
Mike Donnelly SEPAC	Supports the use of the tax cap adjustment. Appreciate restraint in raising tax levy in the past but need to recognize the enrollment increase
Steve Latz Maplewood CBAC	Clarified content of pension reform. Asked about budget materials to be made available before next week's budget forum. Asked about scheduled class size at Seth Boyden, Columbia and at the elementary schools. Also commented on transparency and questioned what documents Mrs. Wright has requested but has not received.

Mrs. Daugherty commented on the public comment regarding funds being returned. The reference was to funds properly reported in the audit, but the state was reducing state aid to offset state funding shortfalls.

Motion made by Mrs. Daugherty, seconded by Ms. Pai, that the Board of Education move to Executive Session to discuss the Superintendent Search, the matters to be announced at a later date. Motion unanimously approved.
