SUPERINTENDENT SEARCH CRITERIA

Mrs. Daugherty introduced Dr. Leroy Nunnery of HYA Associates, the search firm assisting with the superintendent search. Dr. Nunnery presented an outline of the search process including a description of the community engagement process. Dr. Nunnery reported the results of the engagement process including participation rates, common themes including strengths of the district, challenges of the district, and preliminary selection criteria identified in the process.

Selection Criteria were identified in five categories: Academic, Operational, Communication, Professional Skills, and Personal Characteristics.

DISCUSSION

Mrs. Daugherty thanked everyone for their input into the superintendent search criteria. There were many consistent themes that came out of the community engagement process.

Board member comments included the following:

- Appreciation for Dr. Nunnery narrowing down all the information into the succinct list.
- The board of education elect members will be invited to join in the process to hear all the candidates and to have access to all of the information. The new board of education will determine the finalists after January.
- Incumbent to think about process and decide if we should be using the firm that picked the last two superintendents.
- The criteria indicates that we want someone with teaching experience but we need someone with experience and success as a superintendent.
- Need to visit the current district of candidates being considered for superintendent.
- Board members leaving the board will not have to work with the new superintendent. The process should wait until new board members take their seats in January.
