PLEDGE OF ALLEGIANCE

BOARD RECOGNITION - Ms. Crawford

1. SOMSD was awarded a three-year, \$1.5 million grant through the U.S. Department of Education's Carol M. White Physical Education Program (PEP). The award is the largest in the history of the grant program to a New Jersey school district, the first time a New Jersey school district has been awarded the grant twice, and the only PEP grant to a New Jersey school district this year.

Congratulations to Judy LoBianco, Supervisor of Health, Physical Education, and Nursing Services, and her talented staff for their outstanding past work, and for this new opportunity to advance the health and wellness of all of our students.

Thank you also to our partners - South Mountain YMCA, YouthNet, the Maplewood Recreation Department and the South Orange Recreation Department - for joining us in this initiative.

The grant will be used to further develop SOMSD's nationally-recognized physical education program and create a culture of physical activity throughout the community. More information about the grant is available on the District website.

2. The National Merit Scholarship Program has announced that two Columbia High School students were selected as semifinalists in the $59^{\rm th}$ annual National Merit Scholarship competition. Included are:

Christopher Painter Ellie Wren-Hardin These scholastically talented students have an opportunity to continue in the competition and vie for Merit Scholarship awards offered in the spring. Approximately 16,000 semifinalists were selected out of the 1.5 million juniors who entered. Students attained semifinalist status by scoring exceptionally high on the 2012 PSAT taken at the beginning of their junior year. New Jersey's cut-off to become a semifinalist is the second highest in the country.

New Jersey has approximately 500 public and 150 private high schools and less than 23 percent of these schools had any Merit Scholar Semifinalists at all.

These students, along with 34,000 seniors across the country, were recognized for their exceptional academic promise and the high scores they received on the PSAT taken in their junior year.

The 2014 National Achievement Scholarship Program, part of the National Merit Scholarship Corporation, named three Columbia High School students as semifinalists in the National Achievement Scholarship Competition. In its 59th year, just over 1,600 black high school seniors were named semifinalists and will have the opportunity to vie for 800 scholarships. APPROVAL OF MINUTES

Mrs. Daugherty declared the minutes of the Executive and Public Sessions of September 16, 2013 and of the Executive Session of September 30, 2013 approved as presented.

SUPERINTENDENT'S MONTHLY UPDATE - Dr. Osborne

Goal 1

Dr. Osborne congratulated all the National Merit Scholarship program participants.

An update on the implementation of the Common Core State Standards (CCSS) will be presented by the English Language Arts and Mathematics supervisors this evening.

The middle school transformation International Baccalaureate (IB) plan continues to move forward. With 6th graders settled into the newly restructured schedule, work is being done on the development of assessment tools that align CCSS and IB guidelines to measure student growth. This work will be ongoing as we move through the multi-year pursuit of accreditation as IB schools. The work done last year with the after-school initiatives have garnered more interest this year in the Model UN Clubs.

All K-5 grade teachers were trained in ST Math, a self-paced online learning math program, to use with their students. ST Math was selected because of its pedagogy, motivation for students, alignment with CCSS, and its proven record in raising student achievement.

The Columbia High School English Language Arts teachers have begun using iPads as a teaching tool as well as for sharing best practices and collaboration.

SOMS after-school program, All Steamed Up, received a grant from the Dodge Foundation and is an example of how art and science can work together. The program is led by Lisa McPherson and Diane Grant.

Goal 2

Twenty-five teachers volunteered to participate in the Learning Walk training on October 22 which will be followed by classroom visits in various district schools. Thanks to Mr. Memoli and staff who open their classrooms to visits.

The Columbia High School Social Studies Department, through the Diversity Council of Kean University, is hosting two graduate level courses at the high school, *Teaching the Holocaust* and *Prejudice Reduction*.

With the implementation of TEACH NJ, teacher performance will be driven by objective measures that are tied to student learning and District Goals. As required by law and TEACH NJ, the number of observations will double, and this will be accomplished without increasing administrative staff.

All departments and schools are working on the development of Student Growth Objectives based on discipline specific pre-assessment data, and this data will be used as part of teacher evaluations.

Teachers and administrators are transitioning to the use of Reflect, a new software program from Teachscape, that is now being used to complete teacher evaluations.

Columbia High School principal candidate interviews have begun with a panel of 14 staff members and parents. We appreciate Mr. Smith's willingness to act as principal during this interview process.

Goal 3

A K-5 Curriculum Night was held at Clinton School on October 3 with approximately 200 parents attending their choice of six workshops. Topics included ST Math, bar modeling, Singapore Math, computation, using picture books to develop vocabulary and language skills, and more

On October 29 the Parenting Center and elementary school PTA's are hosting an evening with Dr. Scott Barry Kaufman, author of <u>Ungifted - Intelligence Redefined: The Truth About Talent, Practice, Creativity</u> and the Many Paths to Greatness at South Mountain School

Goal 4

The district received its second three-year PEP grant award, this time in the amount of \$1.5 million. Congratulations to Ms. LoBianco and her staff.

Due to more extensive work than anticipated, the Columbia High School pool will not be open at beginning of swim season. Alternate arrangements are being made for the swim team.

The 2012-13 District Audit continues this month with the results being presented at the November Board meeting. The Baseline data for the 2014-15 budget development will be presented in November as well.

A Community Forum on the district's capital plans will be held on Thursday, October 24 at 7:30 pm in the Columbia High School Library. The community is encouraged to offer opinions regarding the future of the pool. Members of the two municipal governments have been invited to attend. A tour of the facility will be available prior to the forum.

Ms. Karriem gave a negotiations update with the statement that, with the help of a mediator, the two sides have reached a tentative agreement pending ratification of SOMEA and approval by the Board of Education.

DISCUSSION

PEP Grant Award - Ms. LoBianco

Dr. Osborne introduced Ms. Judy LoBianco, Supervisor of Physical Education, Health and Nursing Services, who spoke about where the funds from the \$1,500,000 grant will be used, such as partnering with the YMCA and Recreation Departments of South Orange and Maplewood. She thanked everyone for their support.

<u>Common Core State Standards (CCSS) Implementation</u> - Ms. Hanratty,
Ms. Gregory

Dr. Osborne introduced Dr. Furnari, Assistant Superintendent for Curriculum, who detailed the structure of the English Language Arts Standards necessitated by the implementation of the new Common Core State Standards.

Dr. Furnari then introduced Ms. Hanratty, K-5 English Language Arts Supervisor, and Ms. Gregory, 6-12 English Language Arts Supervisor who presented a powerpoint presentation explaining the curriculum changes about to be implemented to align with the Common Core State Standards. Highlights of the presentation are as follows:

- Preparing for the Core in Reading and Writing is being done by introducing new lessons, implementing assessments and benchmarks; and adoption of new books and revisions to thematic units for the upper grades.
- Three major shifts will be to build knowledge through contentrich non-fiction; reading, writing and speaking must be grounded in evidence from text; and regular practice with complex text and its academic language.

The Board members had a chance to comment and ask questions that included:

- Elaborate on strategies our teachers are using.
- Give an example of a complex text.
- How will CCSS impact students at lower levels and how will it help them perform better?

Dr. Beattys, 6-12 Mathematics Supervisor and Ms. Beane, K-5 Mathematics & Science Supervisor, continued with the mathematics portion of the presentation:

• Implementation of CCSS is to create interactive mathematics learning communities in which the student-teacher hierarchy gives way to collective ownership of the mathematics.

- Examples of math lessons were shared.
- The Standards of Mathematical Practice cause a shift in the instructional paradigm, changing the actions teachers take and the learning students evidence.

Ms. Kritzberg left at 9:40 p.m. 9 BOARD MEMBERS PRESENT

The Board members had a chance to comment and ask questions that included:

- How do the CCSS relate to all the opportunities we currently offer in math?
- Communication to parents is important to notify them of the changes.
- Do the CCSS call for any changes in how we deal with automaticity?

Board Goals 2013-14

Changes have been made to bullet point #8 and the changes will be included in the resolution that will be voted upon tonight as follows:

- Improve transparency of Board and committee work
- Maintain timeliness of Board response to public inquiries
- Create informal opportunities for meaningful communication between the Board and the public, and the Board and teachers
- Evaluate the Board's use of technology to facilitate and enhance communication with the public

Harassment, Intimidation & Bullying, and Violence & Vandalism - Mr. Roth

Mr. Roth presented the data as reported to the New Jersey Department of Education. It was reported that the district had 114 incidents of violence and vandalism in 2012-13, down from 180 the previous year, and 36 incidents of HIB which had been unreported previously [report on file in Board Secretary's office].

Board members discussed their concerns with the number of some of the incidents and asked what is being done about them.

Dr. Osborne said the administration shares the Board's concern and can formalize a response to the Board.

Dr. Osborne asked for feedback on the draft presented this evening.

The committee discussed Policy 5512 HIB, report for observations, Board Goals to focus on getting more revenues, and ASCA performance bonuses.

Finance, Facilities & Technology - Mrs. Wren-Hardin

The committee reviewed budget analyses and added one for Energy Usage. Also discussed the long range capital plan including discussion about partnerships related to the high school pool. QSAC which will be voted upon this evening was reviewed, and discussion took place regarding the new PEP grant.

Excellence & Equity - Dr. Gaudelli

The committee has had two meetings since the last Board meeting and discussion included the academic placement policy and level distinction within courses, and review of tonight's presentation on Common Core State Standards.

Engagement & Outreach - Mr. Giles

The committee discussed Board Goals and communication, especially to develop and implement communication strategy to introduce $5^{\rm th}$ and $8^{\rm th}$ grade parents to middle and high school; streamlining of the website and the recent survey results for people's satisfaction with the district website.

Policies - Mr. Stern

Mr. Stern reviewed policy $5512 - 1^{st}$ Reading, and stated that there are no changes to other policies that are up for 2^{nd} readings tonight.
