- 1. Eleven Columbia High School Students were accepted in the North Jersey School Music Association's Honors Chorus: senior, Christelle Daceus; juniors, William Bolles-Beaven and Siobhan McLennon; Sophomores, Olivia Calabrese, Natalie Dix, Hannah Nye, Vivienne Longstreet, and Russell Pinzino; and freshmen, Carolyne Leys, Grace Savoia-Di Gregorio, and Isaiah Thomas. Grace was also selected as a member of the 2013 National Honor Choirs for the American Choral Directors Association. Grace will be singing in the Junior High/Middle School National Honor Choir in Dallas, Texas in March of this year. This is the first time that 11 students have been selected from a single school for the North Jersey School Music Association's Honors Chorus. Ms. Jamie Bunce is the Director of Choral Activities.
- Columbia High School Student, Michael Ferranti, a freshman member of the CHS honors wind ensemble, was selected as a member of the 2012-2013 North Jersey Junior Region Band for his audition on the trumpet.

Three members of the CHS Honors Wind Ensemble were selected as members of the 2012-2013 North Jersey Area Symphonic Band. Junior Ryan Morey will be joining the Area Symphonic Band for the second year in a row and this year his score earned him the third overall chair in the trumpet section. Ryan will also be joining the Region Brass Ensemble this year. Ryan was also selected for the Region Symphonic Band, the only CHS student accepted this year. Junior Nathaniel Pham was accepted to the North Jersey Area Symphonic Band on flute, and was also accepted into the Region Flute Choir.

Sophomore Matthew Schilling was accepted on bass clarinet and also earned a qualifying score on both alto clarinet and contrabass clarinet.

3. The new Math Counts teams at Maplewood Middle School and South Orange Middle School each had an impressive showing at their first regional competition, in West Orange on February 2, 2013.

Isaac Schmidt from Maplewood Middle School placed 3rd overall and is going on to compete in the state championships.

In addition, Maplewood Middle School Student Charlotte Steiner and South Orange Middle School Students Adam Friedman-Brown, Eliana Schulman, Anshul Vyakarnam, and Isabelle Wendt all placed in the top 25% of competitors.

South Orange Middle School was named $Best\ New\ School$ in the competition winning 10^{th} place among all teams, and Maplewood Middle School was ranked 11th.

Maplewood Middle School Teacher, Julie Skrivanic and South Orange Middle School Teacher Jackie Witt, led the district's Math Counts Teams.

- 4. Sarah Bayless, a Junior at CHS, competed in synchronized skating in Sweden representing the Junior Team USA.
- 5. Rodney Cenat won the county championship in wrestling in the 285lbs weight class.
- 6. The Columbia High School Boys Track Team won the Group 4 North 2 Sectional Championship in Toms River. Sydney Scruggs won the 55 meter hurdles and Josh Nijman was shot put champion. Emanuel Grant won the 400 meter race.
- 7. The Columbia High School Girls Track Team won the Group 4 State Championship. Olivia Baker won three gold medals, including for the 400 meter run and the 800 meter run.
- 8. Columbia High School dance teacher, Kandice Point-Du-Jour, was named the K-12 Dance Educator of the Year by the New Jersey Association for Health, Physical Education, Recreation and Dance (NJAHPERD). Ms. Point-Du-Jour received this prestigious award at a Banquet held on February 24, 2013.
- 9. South Orange Middle School Librarian Elissa Malespina, was published in the February/March 2013 of the School Librarian's Workshop. The article entitled "Getting Pinned," appears in the "Tech Talk" section of the newsletter and provides information on the fast growing social network, Pininterest.
- 10. Columbia High School former athletic director, science teacher, and lacrosse coach Robert Curcio, was inducted into the Directors of Athletics Association of New Jersey (DAANJ) Hall of Fame which recognizes athletic administrators who have attained excellence and

contributed a positive and dynamic impact upon student-athletes, high school communities, coaches and colleagues.

11. Beth Dalzell, CHS special education math teacher, was awarded her doctoral degree from Nova Southeastern University.

SUPERINTENDENT'S MONTHLY UPDATE - Dr. Osborne

Thank you to "Unaccompanied Minors" and "Knights of Columbia," Columbia High School a capella groups, that performed this evening before the start of the meeting.

Goal 1

- Work continues in Tuesday meetings to develop IB MYP unit plans to pilot this spring.
- A Daily Learning Objective is an important component of learning. A goal at each middle school is to have an objective posted for students every day. Parents are encouraged to ask their child, "What was the learning objective in (subject) today?"
- We are seeing positive results in expanded middle school after school activities.
- In an effort to provide interventions at earlier grades, kindergarten teachers were given "sensory baskets" to assist students who are experiencing sensory issues.
- The District Management Council will attend the March meeting to give a status report.
- A new Pre-K Applied Behavior Analysis class will open in March.
- More students have participated in Advanced Placement qualifying exams than ever before.

Goal 2

- There were many professional development opportunities in the past month, including NJASK prep, Math in Focus, Edmodo, and Sheltered English Instruction.
- The format and process for arriving at a summative evaluation for teachers has been finalized.

- A monitoring report on cycle one evaluations is in Board packets tonight.
- We are awaiting draft regulations that will govern teacher and principal evaluations beginning in September.

Goal 3

- A kindergarten information session was hosted and well attended.
 Thanks to all who served on the panel and for all those involved.
- Upcoming Events are Big Read celebrations and the Curriculum Night has been rescheduled for March 21st at Jefferson School.
- New Today's Schools on the implementation of International Baccalaureate in middle schools is available on demand on the district website and was broadcast on SOMATV.
- The Safe Route to Schools program is being piloted at Tuscan School in partnership with the Maplewood Police department to develop sustainable long term solutions to dramatically improve safety and reduce traffic in the vicinity of Tuscan School.

Goal 4

- The 2013-14 budget discussion will continue with a presentation later in the meeting.
- Kindergarten registration is being held currently. Open registration for all grades will begin on May 13th.

The contract with SOMEA will expire June 30, 2013.

Ms. Karriem, as Chair of the SOMEA Negotiations Committee, indicated that the Board is deeply committed to settling by June 30, 2013. The committee has been meeting regularly and has reached out to the Union to begin negotiations, but the Board has been notified that the Union will not be ready to meet until early March. The Board is disappointed and anxiously awaits the first meeting date.

More students took qualifying exams for AP courses than before. The development of a master schedule for AP classes would not include any new courses next year but may include some changes in 2014-15. The committee suggests minor changes as to how curriculum is developed, reviewed and revised. A number of students are taking online courses for enrichment, not just for credit recovery.
