BOARD RECOGNITION - Read by Ms. Crawford

- 1. The Columbia High School Varsity Robotics Team advanced to the state Championship to be held on February 9th at the New Jersey Institute of Technology after finishing on the winning alliance against 36 of the best robotic teams in New Jersey. The Columbia High School Junior Varsity Robotics Team also advanced to the state finals and finished third place in the *Inspire Award* category held on January 12th. The CHS Robotics Team was named South Orange's Villager of the month for January 2013. Both Robotics teams are coached by CHS physics teacher, Allan Tumolillo.
- 2. The Columbia High School Student Council was awarded for having a top 10 project for the seventh year in a row by the NJ State Association of State Student Councils. The state only selects 10 projects to consider for the "top 10" category each year. Beth Dalzell and Hannah Edelman are advisers to the Student Council.
- 3. Tuscan Elementary School Assistant Principal, Kevin Mason, will be featured in the documentary, *From Fatherless to Fatherhood*, a film and initiative that explore the causes, effects and possible solutions to father absence in African-American communities. The screening will take place at Maplewood Memorial Library on February 7th.

The Columbia High School Robotics Club coach Mr. Tumolillo and members of the club were present and had one of their robots present a document to the Board president.

Mrs. Wren-Hardin read the memorials and Ms. Crawford announced the retirement, both of which will be voted upon in the action part of tonight's meeting.

Mrs. Daugherty declared the minutes of the Executive and Public Sessions of December 17, 2012 and the Public Session of January 9, 2013, and the Executive Session of January 14, 2013 approved as presented.

SUPERINTENDENT'S MONTHLY UPDATE - Dr. Osborne

Goal 1

- International Baccalaureate program in the middle schools is moving forward. Teachers met for peer feedback on work, and are working on progress and problem solving at Tuesday staff meetings.
- Elementary level working groups have been formed in the areas of scheduling, professional development, progress and reports, and gifted and talented.
- For the first time, all 10th and 11th graders took Advanced Placement qualifying exams for Language Arts.
- The District Management Council is continuing to meet with the Reading Committee and the Inclusion Committee.
- The Fine Arts Department performance this month was very well attended. An additional 50 students are taking Suzuki violin classes, doubling the size of the program.
- Elementary interim reports and midterms at secondary levels are being sent home this week.

Goal 2

- Professional Development offered this month is focused around core curriculum standards.
- There is a growing number of teachers involved in Learning Walks, part of Framework for Teaching.
- Regulations for evaluations for next year will be released in March. We are well positioned on the teacher practice side but still waiting for direction on what will be expected on the teacher learning side.

Goal 3

- Dr. Osborne's State of the District presentation and the written report is available on the district's website.
- An Open House for Realtors was held at Columbia High School with approximately 50 in attendance.
- The first Superintendent's Book Club meeting was held to discuss <u>Mindset</u>.
- A Kindergarten Question and Answer workshop for parents will be held Saturday, February 2.
- The Parenting Center event on motivating your child will be held on February 5.

- Big Read Celebration at each school will be held on February 28.
- There will be an update on the Strategic Communications Plan later this evening.

Goal 4

- There will be a 2013-14 Preliminary Budget Update later this evening.
- Work is continuing on reviewing and updating security plans as needed.
- The district is pursuing capital improvements and updating the capital plan. Work on the Maplewood Middle School addition has begun.
- Several schools have experienced heating problems this month and our Maintenance Department has been working to address them.
- Early registration for kindergarten students begins on February 11th for siblings of current students, February 19th for other kindergartners, and May 13th for all grades.

The contract with SOMEA will expire June 30, 2013.

2013-14 Budget Discussion - Mrs. Schneider

Mrs. Schneider narrated a power point presentation on the 2013-14 preliminary budget update.

The presentation highlighted the following:

- Guiding budgeting principal is District Goal Four
- Alignment of budget to district goals and strategy
- Comparative spending to other districts
- Revenue assumptions and historical trends
- Spending decisions
- Redirect resources to impact student achievement
- Estimated tax impact

The presentation was followed by a discussion with Board members.

Strategic Communication Plan - Ms. Turner

The plan's vision and mission were discussed through three goals:

1. To enhance the school district's positive profile, increasing

the community's trust and confidence in the district through consistent and effective communication of initiatives and accomplishments.

- 2. To engage parents in their students' education by providing regular information about the curriculum and students' progress.
- 3. To respond promptly and reassuringly to crises and challenges.

Upcoming parent events, transparent budget communications support, public relations campaign for capital projects, website enhancements and satisfaction surveys are current priorities of the plan.

Board members had an opportunity to ask questions for clarification.

Naming Rights

The ACHIEVE Foundation approached the Board of Education to discuss the possibility of naming rights to continue to raise funds for the Columbia High School Auditorium Renovation. A resolution to establish guidelines for naming rights is on the agenda tonight.

Committee Reports

<u>Finance, Facilities & Technology</u> - Mrs. Wren-Hardin The committee will meet tomorrow to discuss partnerships relative to plans for the high school pool. Capital projects were also discussed.

Excellence & Equity - Dr. Gaudelli

Assistant Superintendent for Curriculum & Instruction, Lydia Furnari, met with the committee with updates on the Gifted & Talented Program strategies that include further planning through the 2013-14 school year and implementation in 2014-15. The committee continues to discuss the possibility of adding AP courses at the high school. The District Management Council reported that the Reading Initiative is going well and efficiencies of Special Education offerings are being reviewed at this time.

Engagement & Outreach - Mr. Giles

The committee is assessing communications vehicles including a communications survey to be circulated to stakeholders; survey results will be shared with the Board in April. Committee members will facilitate the Board Retreat in March to discuss the mission statement and the achievement gap. Plans to develop a twitter account are underway to increase Board communication. The next Board Office Hours will be held during the evening of February 21st at the South Orange Library. Even though a large number of people are not taking advantage of the opportunity, the open hours remain a good informal way to talk with those who stop by.
