- Approved all Consensus Items.
- Adopted a resolution to send to the governor, local elected officials and the NYSED regarding the Zero Emission Buses Implementation Timeline requesting additional time to meet the mandate.
- Approved the District Safety Plan for the 2024-25 school year. ([link it here](#))
- Established the tax rates for 2024 now that all equalization rates have been finalized by the local towns. When setting the tax levy at \$72,048,709, the tax rate in the Town of Orchard Park will increase by \$0.69/1000 or 1.85%.
- Declared library books from South Davis and a district laptop as surplus/obsolete.
- Approved a change order for phase 1 of the capital project in the amount of \$117,277 for enchantments to the athletic parking lot reconstruction project.
- Approved the 2022 & 2023 internal audit corrective action plans.
