## NYSED Proposed Amendments

Mr. Lilleck reminded the Board about the information he has shared information regarding potential changes to athletics. The New York State Education Department (NYSED) has proposed amendments to sections of the Regulations of the Commissioner of Education relating to Mixed Competition and Extra Class Athletic Activities. Most notably, the proposal would open opportunities for boys to play on girls' sports teams and girls to play on boys' sports teams regardless of potential adverse effects.
