	Special Presentation/Discussion: APHS Athletic Complex Storage Unit Mr. Victor and Mr. Danosky have been exploring storage options to use in the new storage space in the stadium area to accommodate all the football equipment. Currently the football equipment is stored in the multiplex, causing all other sports to find storage homes in other spaces including hallways. They chose Casper Corporation's Space Saver products. The shelving units are built to maximize space in open areas. Mr. Victor is here with a PowerPoint presentation for the board and will any questions that you may have tonight. This purchase will be on the August 14 th agenda for consideration.
	We will have three units on tracks that slide to get 1610 feet of thing stored in 230 feet of space in a nice, organized fashion. Quote is about 47,247.52 for the unit, delivery, and installation. This comes with a 5-year warranty. If anything gets damaged it is easily replaceable. The units can also be reconfigured to meet changing needs.
