DISCUSSION

5. Superintendent's Report 5.1. Communications/Recognitions

- 5.1.1 A big THANK YOU to our downtown businesses, who welcomed over 1,000 kids on Halloween and made it a truly special morning. Your efforts brought joy to so many families in our community.
- 5.1.2 Congratulations to Mr. Stovall on completing the Ironman California! On October 27th, Matt took on one of the most intense physical challenges out there—a full Ironman triathlon. This 140.6-mile journey included a 2.4-mile swim, a 112-mile bike ride, and a full 26.2-mile marathon. Way to go, Matt!
- 5.1.3 We've had three successful Safety Days at Lincoln, Washington, and Rafer schools. The Eagle-1 Helicopter landing at Rafer and Washington Schools was a special highlight. Thank you to Linda Simmons and the District Liaisons for coordinating these important events and ensuring our students learn about safety in engaging ways.
- 5.1.4 The Digital Literacy Classes for Parents, led by Maxine Balling through Fresno State, has filled a need for families. This dedicated group of parents and caregivers recently had a "big" night learning how to save images and attach them to emails. Students were particularly intrigued by the CC and BCC email functions. Mrs. Balling has also brought in a guest speaker who has helped these parents get connected with adult education and courses that could be life-changing for them. Fresno State's generous Chromebook donations are raffled each week, with eligible students receiving their Chromebooks at the final class. Thank you, Fresno State, for supporting this initiative.
- 5.1.5 Reagan's "Don't Fall into Bullying" event was a resounding success, with over 200 students, families, and community members participating. The event highlighted bullying prevention, kindness promotion, and engaging activities led by our talented student leaders. One standout moment was the Poster Contest, where 51 students showcased their creativity with positive posters about kindness and anti-bullying. From interactive booths to a kindness challenge, the evening was filled with impactful conversations and fun. Thank you to everyone who contributed to making this night so memorable!
- 5.1.6 The Kingsburg Family Math Festival was an incredible night. Over 200 attendees enjoyed exciting math games, challenges, delicious food, and a free family photo opportunity. Our amazing teachers and staff, along with Rafer student volunteers, made the event unforgettable.
- 5.1.7 Authorable has chosen Reagan Elementary's Expanded Learning Program as its "School of the Week." Students in Beyond the Bell at Roosevelt, Lincoln, and Reagan are collaborating with an author on the behind-the-scenes process of book publishing. These students will help create the book and will each receive a hardcover copy along with an official "Published Author" certificate.
- 5.1.8 Last week, Mrs. Lauren Galli represented our district at the 2024 California Educational Research Association Conference in San Francisco. Her presentation, "How One School Improved Writing by Using Smarter Balanced Data and Improvement Science," was well received.  - 6.1. On November 1st, our certificated came together for our annual Wellness Day, hosted in partnership with the Fresno County Superintendent of Schools.
