6. Consent Agenda

7.1 Superintendent Search and Evaluation Discussion (VSBA and NESDEC)

David DeRuosi from NESDEC presented their process. Sandra Cameron from VSBA presented their process.

7.2 Superintendent Evaluation Vendor Selection

Mrs. Spaulding made a motion to approve VSBA for the superintendent evaluation, seconded by Mr. Cecchinelli; motion passed 5 to 3. Mr. Reil, Mrs. Leclerc, and Mrs. Whalen voted against the motion.

7.3 Superintendent Search Vendor Selection

Mrs. Spaulding made a motion to approve VSBA for the superintendent search, seconded by Mr. Grant; motion failed 5 to 4. Mr. Reil, Mrs. Farrell, Mrs. Leclerc, Mrs. Whalen, and Mr. Boutin voted against the motion.

Ms. Reynolds disclosed she is a Central Vermont Representative on the VSBA Board. An unpaid volunteer, no cash, incentive, or financial gain to support the VSBA.

Mr. Reil made a motion to approve a Comprehensive search with NESDEC for the superintendent search, seconded by Mrs. Leclerc; motion passed 5 to 4. Mr. Reil, Mrs. Farrell, Mrs. Leclerc, Mrs. Whalen, and Mr. Boutin voted for the motion. Ms. Reynolds, Mrs. Spaulding, Mr. Grant, and Mr. Cecchinelli voted against the motion.

7.4 Audit RFP (Briefing Memo - added as an addendum after the meeting)

Mrs. Spaulding made a motion to approve the proposal of MJK conditionally for a new accountant assigned to the FY25 BUUSD audit, seconded by Ms. Reynolds; motion passed unanimously.

7.5 Discuss Officers Elected at Annual Meeting

Mrs. Leclerc addressed the business manager and recommended that she make a resolution to change the articles and update the treasurer information. **Mr. Grant called point of order. Discussion/questions should be directed to the Chair.** Mrs. Perreault shared the elected Assistant Treasurer would step in, that's the guidance received. Appointed at an annual meeting of the public.

8.2 VSBA Business Meeting Update

The delegate doesn't have any updates. Directed people to review everything on the VSBA website.

8.3 Board Discussion - CVCCSD

The plan instituted 6 years ago remains in place with no real changes, but will continue to discuss that at CVCCSD board meetings. The next meeting at Hardwick School District, and everyone is welcome to attend meetings. **Mr. Cecchinelli called point of**

information and corrected Hardwick for Harwood. Mr. Grant called point of information, asking if feasibility was done on what CVCC would need. Ms. Emerson confirmed there was one done in 2019 by consultant Mike DeWeese. SHS campus discussed again as new suggestions were received. Test fit is being done at U32 and one is planned for SHS campus.

8.4 Consolidation Proposal for Feedback

Plan district-wide, all buildings, the possible move of middle grades to SHS. Be specific; talk about conceptual ideas and exploration. Conversation with the board, each building administrator, and administration. Support with a well-thought-out path. Impact on taxpayers, board structure, staffing, and community. Work with someone collectively to share goals and objectives. Add potential regionalization programs. Clarified this is fact-finding only. No decisions are being made at this point.

Approved feasibility - consultant looking at grade configurations in both Barre City and Barre Town schools and how we bring the grades together in a cost-efficient, effective way for serving students.

8.5 Confirmatory Easement Deed

Sam Carlson from Encore attended to answer questions. The current easement is clarified as just for ingress and egress access. This easement allows the ray to be interconnected to the electrical grid through underground powerlines.

Mr. Reil made a motion to approve the easement and authorize the Board Chair and Superintendent to sign the Confirmatory Easement Deed, seconded by Mr. Cecchinelli; motion passed 7 to 1. Mrs. Farrell voted against the motion.
