Minutes of Suffield Town Meeting

December 19, 2024

The Town Meeting of the Town of Suffield was called to order by Town Clerk Michele Urch at 8:03 PM. The Town Meeting was held at the Suffield Middle School, 350 Mountain Road, Suffield, CT.

Upon nomination by Kristen Lambert, 22 Old Farms Lane, with a second by John Murphy, 18 Downing Way, Edward McAnaney, 85 Wren Drive was unanimously elected moderator by voice vote.

There were no additional nominations for moderator from the floor.

Moderator McAnaney asked those in attendance to stand for the Pledge of Allegiance.

Town Clerk Michele Urch read the Legal Notice into record as published in *the Hartford Courant* on December 12, 2024.
