Motion to Cancel Contract of Christina Kerns

I move that the Board cancel the contract of Christina Kern, and do so based upon the following:

- The Board received from the Superintendent the preliminary determination of
 Principal Brooke Busenbark to cancel the contract of Christina Kerns, and the Board received from Dr. Hofer her recommendation that the preliminary determination by
 Ms. Busenbark be affirmed;
- 2. The Board received from Ms. Kerns several documents which she claimed supported her position that her contract should not be cancelled;
- 3. The Corporation provided notice to Ms. Kerns of her rights to private conferences with the Superintendent and the Board, and Ms. Kerns exercised those rights;
- 4. On November 12, 2024, the Board conducted a private conference and heard evidence from both Ms. Kerns and Dr. Hofer regarding the matter;
- 5. Based upon the documents presented to the Board and the evidence presented at the private conference, the contract of Ms. Kerns should be cancelled on the legal grounds of insubordination, neglect of duty, and other good or just cause.

 Specifically, the preponderance of the evidence presented to the Board shows that;
 - a. Ms. Busenbark advised Ms. Kerns that Ms. Kerns needed to obtain from the Indiana Department of Education on or before October 2, 2024 an emergency permit in order to continue in her position as a school counselor.
 - b. Ms. Busenbark also advised Ms. Kerns that Ms. Kerns was required to submit to Ms. Busenbark and the Central Office evidence that Ms. Kerns had obtained the permit;

- Despite these warnings, Ms. Kerns failed to obtain her emergency permit on or before October 2, 2024;
- d. Ms. Busenbark also advised Ms. Kerns on July 1, 2024 that Ms. Kerns was required to make progress on the coursework required to meet licensing qualifications as a school counselor, but Ms. Kerns failed to make progress toward the coursework.
- e. On September 17, 2024, Ms. Busenbark advised Ms. Kerns that Ms. Kerns was required to provide services to any student issues related to educational needs, complaints, and wellness. After that conference, Ms. Kerns refused to provide services to a student, despite the student's history of self-harm and suicide ideation, failed to investigate suicide threats, failed to conduct threat and risk assessments, failed to meet with students who requested or needed support, failed to communicate with parents, and failed to initiate and implement Section 504 conferences, procedures, and plans.
- f. Ms. Busenbark also reported that on several occasions Ms. Kerns failed to be professional and maintain a professional demeanor with students, staff, and visitors, and Ms. Busenbark reported that Ms. Kerns' communication with Ms. Busenbark was often threatening, insubordinate, disrespectful and otherwise inappropriate. The evidence presented supports this behavior which falls below the expectations of school counselors; and
- g. That based upon these facts and the totality of the evidence presented to the Board, a preponderance of the evidence shows legal grounds for cancellation

exist under Indiana Code §20-28-7.5-1, specifically, insubordination, neglect of duty, and other good and just cause.
