She comes to us from the Valley Day School. We look for to both working with our team.

Our School Mental Health and Safety and Security Grant has been submitted to the Pennsylvania Commission on Crime and Delinquency (PCCD). The grant has been accepted.

The van has returned from Maryland to Bob Fisher Chevrolet. We picked it up on 9/30. So far it is working well.
