All schools have limited capacity for school change for the 2025-26 school year

International Baccalaureate (IB) at Edmonds-Woodway High - open to current 8th grade students who reside in the Edmonds School District service area. Students must complete the IB Application and follow the application process for acceptance.

STEM Magnet Program at Mountlake Terrace High – a "Choice Program" available to students in the district. Students must complete the STEM Application with Mountlake Terrace High to be accepted. Nonresident students interested in STEM must also complete the STEM application and a school change application and meet the eligibility requirements to attend the program.

STEAM Program at Lynnwood High – a "Choice Program" available to students in the district. Students interested in attending this program must complete a school change application and meet all eligibility requirements to attend the program. Nonresident students must complete the school change application and meet the eligibility requirements to attend the program.

Additional School Change Information/Guidelines

- 1. Students must be enrolled at their assigned school while waiting for a school change decision (in-district students only).
- 2. It is the responsibility of the parents/guardians to ensure that any conflicts related to the conditions of legally decreed parenting plans and/or court orders are resolved prior to the time the transfer request is considered for approval. After approval, any copies of parenting plans and/or court orders must be provided to the school where the student is or will be attending.
- 3. A transfer may be revoked during the school year when in the judgment of school leadership, the student is not benefiting from the transfer and/or creating a substantial obstacle to the opportunities of other students to learn in an environment free of unnecessary disruptions.
- 4. All applications received by the school change deadline that meet the eligibility requirements will be accepted up to the number of spaces available at the requested school; when space is available, siblings of students who are currently enrolled may be accepted for school change to the same school provided the eligibility criteria are met by the sibling.
- 5. In-district school change is only open to those students who are in good academic standing (No "F" grades and above a 2.0 GPA), have satisfactory attendance (no unexcused absences or excessive tardiness), and have no severe behavior violations (suspensions).
- 6. All applications received after the deadline will be denied; with the exception of siblings of current students and students of employees.
- 7. Out of district families may apply to attend a school in our district. All students who apply to the district will be considered based upon the same criteria.
