School Lunch

Applying for a School Lunch

All families may fill out the online application for the Free or Reduced Meal Program.

- 1. Please go to www.schoolcafe.com.
- 2. Select your language from the top right-hand corner.
- 3. Write down your username and password in a safe place!
- 4. Be sure to correctly indicate if income is weekly, biweekly, or monthly.
- 5. Submit the online application.
- 6. Check your email in 1-2 days to find out if your family qualifies for the free or reduced meal program.

School Cafe Account

School Cafe is where you can put money into your students' food service account that can be used for meals and snacks. You can also see what your student is purchasing and set restrictions there.

- 1. Please go to www.schoolcafe.com.
- 2. Select your language from the top right-hand corner.
- 3. Write down your username and password in a safe place!

Accessing Schoology and Sapphire

Schoology Access

Schoology is where all parents can get information about homework and class assignments for students in the Middle School and High School only.

Schoology can be accessed at <u>schoology.com</u> or the Schoology app on your phone.

To Get a Schoology Parent Access Code and Account:

- 1. Go to www.umasd.org/schoology
- 2. Scroll down to the bottom of the page and complete to form.
- 3. In 1-3 days, check your email for your PIN number.
- 4. When you have your parent access code, go to: http://www.schoology.com.
- 5. Click the **Sign Up** button in the top right corner.
- 6. Select the **Parent** button.
- 7. Enter the access code you received, and click **Continue**.

Enter YOUR OWN name and email (not the student's) and choose a password.

To Add Additional Children to Your Account:

- 1. Click on the downfacing arrow on the top right of the Schoology account.
- 2. Select the option to +Add Child.
- 3. Enter the Parent Access Code for the child you'd like to add to your account.

Accessing Schoology and Sapphire

Sapphire Access

Sapphire allows parents and legal guardians to check their child's grades and attendance. Currently, Sapphire can only show grades for Upper Merion Area Middle School and High School students.

However, attendance records are accessible for elementary students.

You are encouraged to create a parent account to view grades and attendance. You do NOT have to create a new login every year. You create one account for ALL students.

To Get a Parent Sapphire Account Pin

- 1. Go to <u>www.umasd.org/mygrades</u>
- 2. Make sure the popup blocker is turned off.
- 3. Click on the link, "Create a Web Portal account"



- 4. Enter this district keyword.
- 5. Read the Sapphire Community Portal User Agreement, check "Yes" if you agree, and then click "Continue".
- 6. Complete the online application.
- 7. Complete your username and password information. The Upper Merion Area School District does not manage usernames and passwords. If you forget your password, the system will automatically reset your password, if you request it, based on your security question.

Once you have submitted your application, print out the application, and sign it.

Obtaining Internet Access

If your home does not have internet access, please let your counselor know as soon as possible. Your counselor will be able to speak with teachers about a fair and reasonable way for your child/children to complete homework.

Your counselor may also connect you with a district social worker who may be able to help get you affordable internet.

Comcast Internet Essentials

Comcast Internet Essentials is a low-cost internet option available in the Upper Merion Area School District.

Your family may be eligible for the service if:

- Are eligible for public assistance programs such as the National School Lunch Program, Housing Assistance, Medicaid, SNAP, SSI, and <u>others</u>.
- Have not been a Xfinity Internet customer for 90 days.
- Do not currently have the internet.
- Do not owe money to Xfinity Internet from the past year.

- 5. You must click "Save" at the bottom of the Contact tab!



Work Permits

All minors (students under 18 years old) must have a work permit in order to be employed.

During the school year, minors may not work more than 18 hours Monday-Friday during a school week. Minors may not work more than 40 hours a week when school is not in session.

14-15 year olds may not work more than 3 hours on a school day or 8 hours on a non-school day. They may not work before 7am or after 7pm on a school day or after 9pm on a non-school day.

16-17 year olds may not work more than 28 hours during the school week (Monday-Friday) while school is in session. They are permitted to work until 12 midnight on school days. When school is not in session, they may work 40 hours per week and until 1 am.

Requesting a Work Permit

- 1. Parents must bring valid identification (photo not required) that shows the parent name and current address.
- 2. A parent or legal guardian must come to the High School during normal school hours (7:30am- 2:21pm).

During the COVID-19 school closure, work permits may only be picked up on Thursdays from 11:00am- 1:00pm. Please call the high school front desk at 610-205-6400 *Press 3 *Press 2 in order to confirm pick up time before arriving at the high school.

- 3. Let the front desk secretary know that you would like to pick up a work permit for your student.
- You will be brought to the appropriate secretary to help you obtain the work permit.

Upper Merion Area School District fosters an environment for success due in large part to the strong relationship established between the schools and the community. Finally, a significant source of reinforcement parents and guardians can draw upon is their school principal, as he or she sets the school's educational tone. By keeping current with the new ideas and experiences that comprise their children's school day, parents can continue to nurture their children's education in the most critical classroom of all - the home.

Report Card Distribution

Elementary School

Student progress is communicated to parents and guardians through a written progress report/personal conference format. Progress reports for grades kindergarten through 4 are issued in December, March, and June.

Middle School

Report cards are issued four times during the year. If students are doing poorly or are not completing assignments, an interim report is sent home halfway between report card periods. It is important to realize that interim reports are not final marks; grades can improve or decline after interim reports are issued.

High School

Grades are issued for each of the four quarters (grading or marking periods) of the school year. In addition, a letter grade for the final examination and the final letter grade for the course are reported at the same time as the grade for the fourth marking period.



Parent Teacher Conferences

Elementary Schools

Parent/teacher conferences are held shortly after the December and March report periods. Parent/teacher conferences are mandatory in December following the first trimester. Parents and guardians are encouraged to meet with their children's teachers, either at the scheduled conference sessions or another convenient time. Conferences offer a valuable opportunity to discuss students' academic progress, achievements, health, and activities. All grades K-8 will be utilizing the My Conference Time online scheduling system to arrange for parent/teacher conferences.

Middle School

Conferences for parents/guardians of students in grades five through eight are held regularly twice a year. Parents in grades five through eight may request a conference with an individual teacher or a team at any time. Parents should call the appropriate teacher to set up an appointment. All grades K-8 will be utilizing the My Conference Time online scheduling system to arrange for parent/teacher conferences.

High School

Conferences for parents/guardians of students in grades nine through twelve are held regularly twice a year. Parents in grades nine through twelve may request a conference with an individual teacher or a team at any time. Parents should call the appropriate teacher to set up an appointment.

Clearances for Volunteers and Chaperones

If you volunteer in the Upper Merion Area School District, you need to be aware of the following information for the upcoming school year:

- 1. Volunteers will be required to obtain the PA Criminal History Clearance and the PA Child Abuse History Clearance; and
- 2. Volunteers will be required to obtain the PA FBI Federal Criminal History Report if they have not been a Pennsylvania resident for ten (10) consecutive years prior to the date of their volunteer application. If, however, you have resided in Pennsylvania for ten (10) or more consecutive years, you may complete the affidavit section of the Application; and
- 3. Upon submission of credentials to volunteer, all clearances must be dated no later than twelve (12) months prior the date of submission. Volunteers must renew clearances and affidavits every five (5) years from the date in which they were issued in order to remain in compliance.

<u>Treatment</u> services require a comprehensive clinical and financial assessment. Trained Case Managers perform these assessments in order to determine the most appropriate funding resource and level of care, and to find the provider best suited to meet an individual's treatment needs.

Recovery support services are non-clinical services that assist individuals and their family members to recover from substance use disorders. These services are supplemental to a treatment program and focus on outreach, engagement, education and other strategies to assist individuals in engaging, maintaining and sustaining long-term recovery. Recovery Support Services are also available to family members of individuals in various stages of recovery, through the utilization of Certified Family Recovery Specialist services and/or parent support groups.
