

The Eufaula City Board of Education met in special session on Wednesday, March 23, 2022 in the board room at Central Office. Members present were: Mrs. Twana R. Purifoy Anderson, Mrs. Yadira Chavez, Mrs. Caty H. Richardson, Mr. Richard W. Wingate, and Ms. Katrina L. Wright. Visitors present included Zane Johnson, Brandon Kiser, Frederick Lynn, Tywon Jackson, Harmony Jackson, and Ursula Lindsey.

The notice of this meeting was posted on the public bulletin board in the central office and a notice was sent electronically on March 18, 2022 to a list of people who request board meeting information.

1. Mr. Richard W. Wingate called the meeting to order at 5:31 p.m. A quorum was established with all members present. Mrs. Caty H. Richardson moved for the board to approve of the agenda as presented, and Mrs. Yadira Chavez seconded the motion. Motion was approved with a unanimous vote. Voting was as follows: “AYE” – Anderson, Chavez, Richardson, Wingate, and Wright. “NAY” – None.

2. New Business

Mrs. Yadira Chavez moved that the Board go into executive session at 5:32 p.m. for a student hearing. Mrs. Twana R. Purifoy Anderson seconded the motion. The executive session was estimated to last approximately thirty minutes. Motion was approved with a unanimous vote. Voting was as follows: “AYE” – Anderson, Chavez, Richardson, Wingate, and Wright. “NAY” – None.

Following presentation of facts and evidence and subsequent deliberation in executive session, the board reconvened in open session at 6:16 p.m. to receive the recommendation of the Superintendent.

- A. Student Hearing, #2022-004: The Superintendent recommended that Student ID #2022-004 charged with violation of the Student Code of Conduct 3.13, Fighting, be expelled from Eufaula City Schools for one calendar year. Ms. Katrina L. Wright moved to accept the Superintendent’s recommendation regarding Student ID # 2022-004 based on evidence as presented. Mrs. Caty H. Richardson seconded the motion. Motion passed with a majority vote. Voting was as follows: “AYE” – Chavez, Richardson, Wingate, and Wright. “NAY” – Anderson.
- B. Student Hearing, #2022-005: The Superintendent recommended that Student ID #2022-005 charged with violation of the Student Code of Conduct 3.13, Fighting, be expelled from Eufaula City Schools for one calendar year. Mrs. Twana R. Purifoy Anderson moved to accept the Superintendent’s recommendation regarding Student ID # 2022-005 based on evidence as presented. Mrs. Yadira Chavez seconded the motion. Motion passed with a unanimous vote. Voting was as follows: “AYE” – Anderson, Chavez, Richardson, Wingate, and Wright. “NAY” – None.

3. Adjourn: There being no further business to discuss, Ms. Katrina L. Wright moved that the board adjourn. Mrs. Caty H. Richardson seconded the motion. Motion was approved with a unanimous vote. Voting was as follows: "AYE" – Anderson, Chavez, Richardson, Wingate, and Wright. "NAY" – None.
