



TUITION DISCOUNTS, FEES, and PAYMENT OPTIONS

REGISTRATION FEE: \$250 is due at registration and is non-refundable. This fee will be deducted from your total financial obligation after payment is made.

TUITION DEPOSIT: \$600 is due at registration. This deposit will be deducted from your total financial obligation after payment is made.

TABLET/PC FEE: \$1,940 includes tablet/pc and software while the student is attending McNicholas. Freshmen may pay this fee over four years (\$485/yr.)

MULTIPLE STUDENT TUITION DISCOUNT: \$1,000 credit will be applied to the second and third students enrolled. (This discount will not apply if any student is receiving a scholarship or other award valued at 50% of tuition or higher, excluding state of Ohio scholarships.)

PAYMENT PLANS: McNicholas offers pay in full, 2-pay, 4-pay, and 10-pay payment plans. See FACTS for more details. Families are required to select the same payment plan for all siblings.

FULL PAYMENT DISCOUNT: \$200 is given when payment in full is made by May 15, 2025. (This discount does not apply for students receiving a scholarship or other award valued at 50% of tuition or higher.)

SAIL PROGRAM FEE: \$5,750 is charged for students enrolled in this program and is in addition to tuition.

STATE SCHOLARSHIPS: All Ohio students are eligible for a state-funded scholarship. For those eligible for an EdChoice Scholarship, McNicholas made a prediction of your state scholarship award based on information obtained from the Ohio Department of Education and/or your FACTS application. The amount listed is an estimate and could change upon receipt of additional financial information. The Jon Peterson Scholarship requires an IEP/ETR accommodation plan and awards are based on the primary condition identified on the ETR. All state scholarships are contingent upon the parent/guardian completing the state scholarship application, which is anticipated to open in February 2025 for the 2025-26 school year. Should your estimated state scholarship amount differ from the amount awarded by the state of Ohio after application, your FACTS account will be adjusted to reflect the awarded amount. No award from McNicholas will reduce the tuition due to less than \$0.

FINANCIAL AID: McNicholas expects state scholarship awards to provide the first dollars towards meeting your family's financial need. Therefore, a family must complete a valid application for a state-funded scholarship and designate it for McNicholas tuition in order to receive a financial aid award from McNicholas. We have adopted this policy to assist as many families as possible with demonstrated need. Factors such as the amount of tuition aid available, number of applicants, and overall family financial need are considered. All financial aid awards are for one year only. Families must reapply each year. Financial aid awards may incur a re-assessment if there is a significant change in your anticipated state-funded award.
