A **mandatory** pre-bid meeting for the 2025 Stadium Bleacher Repairs Washburn High School project will be held Tuesday, February 4, 2025. Bids will be received via email at rfa@mpls.k12.mn.us **AND** diedra.geve@mpls.k12.mn.us until the date and time specified above. There will be a virtual bid opening at the date and time specified above. If you would like to be included for the virtual bid opening, please email diedra.geve@mpls.k12.mn.us and you will be sent a link to the virtual bid opening.

Bids must be accompanied by a bid deposit of 2% of the total amount bid in the form of a certified check or bidder's corporate surety bond made payable to Special School District No. 1. Include a PDF copy of the certified check or bidder's corporate bond when you email your Bid Form.)

Special School District No. 1 reserves the right to award this bid in part or in whole to a single supplier or to reject any or all bids if it is in the best interest of the School District to do so. Bids must be typewritten or handwritten and include handwritten signature in ink.
