 - Budget reflects costs of actual plans our staff members are currently in
- Retirement and Social Security Budget are calculated based on TRS, ERS and FICA rates and are assessed based on actual salary figures.

Modifications to Transfers & Debt Service Budget in 2023-24

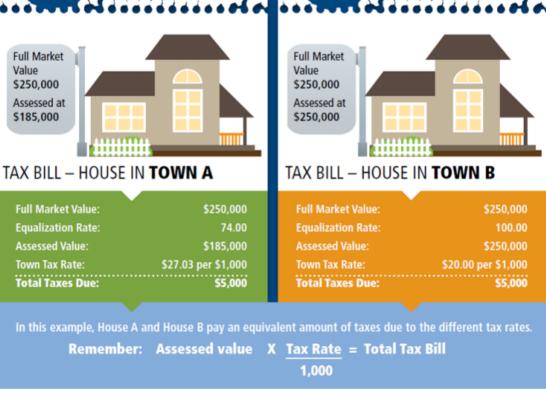
Slight increase to overall debt service budget
 ➢ Offset by equal increase in Building aid
 ➢ Debt service obligation remains flat

2023-2024 Property Tax Summary

- Full value tax rate is projected to Increase by 1.28%
 - Projected to be at the rate of \$21.61 per \$1,000 of property value in 2023-2024 compared to a rate of \$21.33 per \$1,000 of property value in 2022-2023, depending on assessed values of properties in municipalities and equalization rates
 - **Point of Reference:** The 2022-2023 rate was <u>projected</u> at \$21.49 in May 2022, and was calculated at \$21.33 in August 2022.
 - The \$21.33 rate per \$1,000 of assessed value is the <u>actual blended tax rate</u> (of all four municipalities) for 2022-2023; and the \$21.61 rate per \$1,000 of assessed value is the <u>estimated blended tax</u> rate (of all four municipalities) for 2023-2024.
- Equalization Rates: Determined by the Office of Real Property Tax Services Without a town reassessment to determine a properties current worth, the rate is designed to bring property up to Market Value.
 - Properties are assessed taxes based on Market Value, not assessed value
 - Equalization rates are currently estimated by the Office of Real Property Tax Services at 70% for the Town of Brighton, 80% for the Town of Chili, 99% for the Town of Caledonia, and 100% for the Town of Wheatland Will be finalized by August 2023
 - Rates are set to assess tax at market value (see next slide for graphic).

Equalization rates indicate the ratio of the assessed value to market value in the municipality. They are used in an effort to fairly apportion the share of taxes when a taxing jurisdiction, such as a school district, contains multiple municipalities. They are designed to ensure that owners of properties with similar full market values pay an equivalent amount of taxes.

Although tax rate is higher in Town A – The taxes due remain the same for a house with a full market value of \$250,000

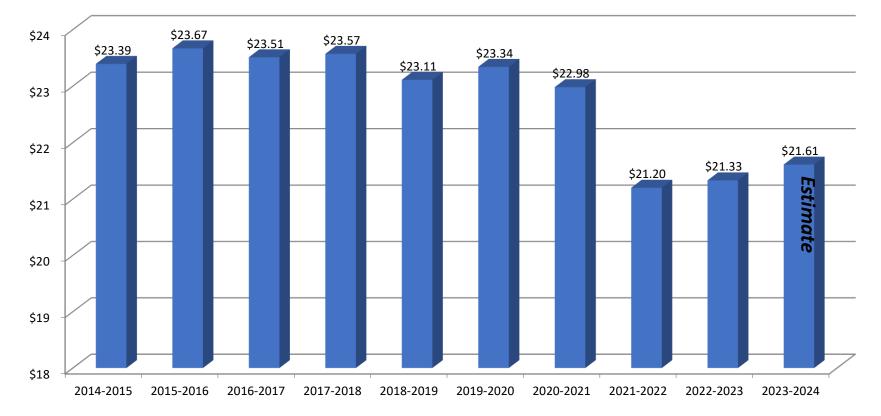

• 2023-2024 School Budget in the amount of **\$22,242,171**

- Proposition #2 Capital Reserve Fund 2018 (Bus and Grounds Equipment)
 - Authority to purchase the following items in an amount not to exceed \$235,000:
 - One (a) replacement vehicles for the transportation of District students, that vehicles being **one (1) 65-passenger bus**.
 - Also being purchased is **one (1) service vehicle with plow** to be used for grounds and bus fleet maintenance.

- Proposition #3 Capital Reserve Fund 2021 (School Equipment)
 - Authority to purchase equipment to support instruction in an amount not to exceed \$50,000.

Proposition #4 – Establishment of Reserve Fund

- Establish Capital Reserve Fund 2023 (Facilities) with a term of ten years with an ultimate amount of \$2,775,000
 - NOTE: Through this action the reserve is established but not funded
